

D-288™ MOISTURE VAPOR RETARDER

D-288 Moisture Vapor Retarder is a one part, trowel applied, elastomeric anti-fracture urethane membrane formulated to reduce moisture vapor transmission from the subfloor. It also creates a noise reduction barrier, establishes an anti fracture membrane capable of bridging cracks in the substrate up to 1/8" wide. D-288 may be used over all substrates common to hardwood flooring installations including; concrete, plywood, particle board, or chip board (underlayment grade), well bonded vinyl, ceramic tile, cement backer board, cement patches and underlayments, radiant heat flooring and terrazzo.

DURALEVEL 83P is suitable for thicknesses from featheredge to 1" thick, or up to 5" thick when mixed as designed with pea gravel. Use on, above or below grade. Use DURALEVEL 83P in smaller installations where it may be mixed by hand, or underlayment pump to quickly cover large jobs.

WEBCRETE 95 is extremely flexible and resilient for use to patch and smooth floors prior to the installation of ceramic tile, carpet, resilient and wood flooring. When mixed with D-L16 instead of water, not only is the performance and flexibility improved, but WEBCRETE 95 can also be used as an embossing leveler.

Once cured, D-332 is completely waterproof providing a tough, flexible, tenacious bond to a variety of surfaces. D-332's elastomeric characteristics allow it to move with the wood as it expands and contracts.

D-332 may be used to adhere all engineered, acrylic impregnated, solid plank flat milled, shorts, bamboo, cork, and parquet hardwood flooring designed and recommended in writing by the hardwood flooring manufacturer for glue-down applications. This adhesive can also be used to install plywood as described, as well as ceramic tile, marble and stone inlays for light commercial and residential applications.

D-332 may be used over all properly prepared substrate installations: concrete, plywood, particle or chip board, well bonded vinyl and ceramic tile, cement backer board, gypsum patch/underlayments (dry, above grade), cement patch/underlayments, radiant heat flooring and terrazzo.

Once cured, D-321 is waterproof and is not adversely affected by exposure to moisture, water or alkalinity. D-321's elastomeric characteristics allow the adhesive to move with the wood as it expands and contracts over the life of the floor.

D-321 may be used to adhere all engineered, acrylic impregnated solid plank flat milled, shorts, bamboo and parquet hardwood flooring designed and recommended in writing by the hardwood manufacturer for glue down applications.

This adhesive can also be used to install plywood, ceramic tile, marble and stone inlays for light commercial or residential applications. D-321 may be used over properly prepared substrates common to hardwood flooring installations including: concrete, plywood, particle or chip board (underlayment grade), well bonded vinyl and ceramic tile, cement backer board, gypsum patch/underlayment (dry-above grade), cement patch/underlayments, radiant heat flooring and terrazzo.

D-317™ ENGINEERED WOOD FLOORING ADHESIVE

D-317 Engineered Wood Flooring Adhesive is a single component, moisture cure urethane adhesive that may be used to adhere 3-ply or 5-ply engineered wood flooring.

Use D-317 over substrates common to hardwood flooring installations; concrete, plywood subfloors, particle or chip board (underlayment grade), well bonded vinyl, cement backer board, gypsum patch/underlayment (dry, above-grade), cement patch/underlayments, and radiant heat flooring.

This adhesive also can be used to install ceramic tile, marble, and stone inlays for light commercial and residential applications. Do NOT use D-317 to install solid wood flooring.



Use Durabond Urethane Adhesive Remover to remove wet and cured urethane adhesives from the surface of the prefinished (non wax) wood flooring.

TROWELS



Trowel size is suggested to maximize coverage of adhesive. Periodically check coverage of adhesive during installation; greater than or equal to 80% coverage is required for engineered hardwood flooring; greater than or equal to 95% coverage is required for solid hardwood flooring. Uneven subflooring may require the use of either a leveling/patching material, or a larger notched trowel for proper coverage of adhesive.



This general purpose two-component epoxy system is used for all applications that require fast cure time. The epoxy has extremely high bond strength and cures in 5 minutes.

URETHANE ADHESIVE REPAIR KITS

This rapid setting, two-component polyurethane adhesive is used to replace floorboards, repair hollow spots, and to install thresholds and mouldings. The adhesive has extremely high bond strength and flexibility, making it the perfect choice when bonding wood to wood or wood to concrete.

Packaging: Each foil packet contains: 50ml of 100% urethane adhesive, one static mixer and a 1/16" needle. Hardwood Repair Kits are packaged 80 kits per case.



WARRANTY INFORMATION

Adhesive Bond Warranty

Durabond Hardwood Products warrants that Durabond Hardwood Adhesives* will bond all engineered, solid, or acrylic impregnated hardwood flooring, designed and recommended in writing by the wood flooring manufacturer for glue-down, to all substrates common to hardwood flooring prorated for a period equal to the wood flooring manufacturer's product warranty.

Moisture Warranty

Durabond Hardwood Products warrants that Durabond Hardwood Adhesives*, when used in conjunction with a Durabond Hardwood Products Approved Surface Preparation Membrane**, will bond and will protect all engineered, solid, or acrylic impregnated hardwood flooring, designed and recommended in writing by the wood flooring manufacturer for glue-down, against moisture damage through the sub-floor prorated for a period equal to the wood flooring manufacturer's product warranty.

These warranties are contingent upon the following:

- The evaluation of a potential claim by a Bostik, Inc. representative in advance of any replacement
 work, submittal of wood flooring manufacturer's product warranty, and a copy of the original materials
 and installation invoice(s). Any repairs conducted prior to evaluation will void all warranties.
- The adhesive must be used in accordance with Durabond Hardwood Products most recent published literature.
- The wood flooring must be installed in accordance with the wood flooring manufacturer's most recent published literature pertaining to glue-down installations, including but not limited to, wood flooring acclimation, expansion space, jobsite temperature, relative humidity and air flow requirements.
- The installation must be maintained in accordance with the wood flooring manufacturer's recommendations including, but not limited to, temperature, relative humidity, and proper maintenance.
- This warranty does not cover damage due to flooding, hydrostatic head, puddling, improper maintenance, low/excessive relative humidity and/or temperature, or any issues not related to excessive moisture proven to be coming through the membrane.
- This warranty is to the original purchaser and is non-transferable. Durabond Hardwood Products will
 repair or replace the affected flooring one time only.


