Grout Cleaning Concentrate and Efflorescence Remover

PRODUCT DESCRIPTION

Hydroment® Remove™ is a specially formulated, non-acidic, non-abrasive grout cleaning concentrate and efflorescence remover. Hydroment Remove combines powerful surface active agents, wetting agents, and sequestrants which penetrate, soften and remove grout residue, grout haze and latex modified films left on ceramic tile surfaces. Hydroment Remove also safely dissolves efflorescence and other surface stains which can appear on ceramic tile grout joints. Hydroment Remove contains no acids or abrasives which could damage glazed tile or "burn" and discolor grout joints.

RECOMMENDED USE

Hydroment Remove is recommended for cleaning all ceramic tile grout/joint filler, latex modified grouts and to remove grout residue, haze and latex films left on tile surfaces.

When used full strength, Remove is also recommended for removing efflorescence and other stains which are common to cementitious ceramic tile grouts and masonry surfaces.

DIRECTIONS FOR USE

MIXING: Add 8 ounces of Hydroment Remove to 3 gallons of clean, drinkable water and mix by gentle stirring. Avoid the use of high speed mixing.

APPLICATION FOR NORMAL CLEANING/RESIDUE REMOVAL (1/2 TO 1½ HRS. AFTER GROUTING):

Thoroughly wet a turkish towel or 3M® Doodlebug pad with the cleaning solution. Remove excess cleaning solution from the towel or pad. Drag the towel across the tile or form a pad with the towel and clean the tile by moving the pad diagonally across the grout joints and tile face. Rinse the dirty towel or pad in a separate bucket of clean water (not the cleaning solution) and wring out the excess rinse water.

Repeat the above procedure until the tile surfaces are clean. After cleaning, remove any remaining cleaning solution and suspended residue using a clean moist turkish towel. Rinse the towel frequently in clean water and change the rinse water often for best results. Polish the tile with a clean, dry cloth.

APPLICATION FOR STUBBORN RESIDUE/EFFLORESCENCE REMOVAL:

Apply Hydroment Remove full strength and scrub in a circular motion with a 3M Doodlebug pad. After cleaning, remove any remaining cleaning solution and suspended residue using a clean, moist turkish towel. Rinse the towel frequently in clean water and change the rinse water often for best results. Polish the tile with a clean, dry cloth.

LIMITATIONS

- Do not use on marble, brass, aluminum, copper or their alloys. Wear rubber gloves when using this product.
