TERMS AND CONDITIONS

1. Contractor agrees, in installing the membrane roofing and flashings herein described, (A) to use only materials manufactured by Conglas or expressly accepted in the Conglas membrane roofing and flashing specifications; (B) that materials manufactured by Conglas are subject to its standard terms and conditions of sale; and (C) to install and apply all such materials in strict compliance with current Conglas membrane roofing and flashing specifications. The decision of Conglas as to whether the terms and conditions of this agreement have been complied with shall be final. The issuance of a Conglas Roofing Guarantee shall not be deemed conclusive that said specifications have been complied with nor shall it imply any responsibility for design or construction of the building, including the roof system. If Conglas determines that the specifications have not been complied with, and that additional workmanship or materials are necessary to justify the issuance of the requested Roofing Guarantee, the Contractor agrees, at the Contractor's own expense, to complete the work as directed by Conglas.

2. Contractor agrees to pay for the requested Roofing Guarantee in accordance with the current Conglas Guarantee fee schedule. Fees shall be calculated as follows: Number of squares (including flashings) x fee/square **or** minimum fee. (All Series 40 Guarantees require a 50% non-refundable deposit.)

3. Contractor agrees to give Conglas notice by submitting initial guarantee application (yellow copy) not less than 14 days prior to job start.

4. Contractor agrees, without altering or diminishing his responsibilities, for the sole purpose of determining acceptability of the application of the membrane for the issuance of its Guarantee, that the roofing membrane shall be subject to audit by an authorized Conglas employee. Roof cutouts may be taken, at Conglas' discretion, by the roofing contractor for evaluation to determine compliance with Conglas specified tolerances.

5. Contractor agrees that if an audit of the roofing membrane application discloses defective workmanship during the first two years of guarantee coverage, Contractor will make all necessary repairs at his own expense and in a manner satisfactory to Conglas. If said repairs are not made within fifteen (15) days after notice to Contractor, Conglas may have said repairs made and Contractor will make prompt payment to Conglas for such repairs. Contractor must notify Conglas, within 30 days, of any roof leaks within the first two (2) years of completion where a Guarantee has been issued.

6. All completed applications for Conglas Roofing Guarantees (white originals with signed "Notice of Completion") must be submitted within six (6) months after completion of application of Conglas roofing materials. The application must be signed by Contractor and must correctly identify the name under which he does business. If Contractor is a corporation, the corporation name should appear. The request should be signed by the President or Vice-President and Secretary or Ass't Secretary of the corporation, and the corporate seal should be affixed. If contractor is a partnership, the partnership name should be indicated on the first line and the agreement should be signed by one or more partners. If Contractor is an individual, his full, correct name as well as the name under which he is doing business, should appear on the first line.

7. Contractor shall not sub-contract or subordinate installation of Conglas Guaranteed roof systems to anyone other than Conglas Approved Applicators.

8. Issuance of Roofing Guarantee does not imply any responsibility for specifications, design or construction of any portion of the building including the roof system except as stated in the Roofing Guarantee.
