Allow the surface to dry thoroughly. Scrape and sand existing peeled or checked paint to a sound surface. Sand glossy surfaces dull. Concrete and mortar must be cured at least 7 days at 75°F. On tilt-up and poured-in-place concrete, commercial detergents and sandblasting may be necessary to remove sealers, release compounds, and to provide an anchor pattern.</p> <p>Fill bugholes, air pockets, cracks, and other voids and gaps between windows, doors, trim, and other through-wall openings using an elastomeric sealant or patch or the appropriate caulk.</p>

<u>SURFACE PREPARATION</u>	<u>APPLICATION</u>	<u>CAUTIONS</u>
<p>Previously Painted: All old, peeling, flaking paint must be removed. Areas with firm adhesion must be clean and free of dirt, oil, grease, etc. Rinse thoroughly and allow to dry. Remaining paint should be rough sanded in a circular motion to ensure adhesion of Loxon Vertical Concrete Stain. Rinse away sanding dust.</p> <p>Mildew: Remove before painting by washing with a solution of 1 part liquid bleach and 3 parts water. Apply the solution and scrub the mildewed area. Allow the solution to remain on the surface for 10 minutes. Rinse thoroughly with water and allow the surface to dry before painting. Wear protective eyewear, waterproof gloves, and protective clothing. Quickly wash off any of the mixture that comes in contact with your skin. Do not add detergents or ammonia to the bleach/water solution.</p>	<p>For most applications, a minimum of two coats is required for maximum water repellency and uniform appearance.</p> <p>Stir stain thoroughly before and during application.</p> <p>When using more than one container, intermix all containers together to ensure color uniformity.</p> <p>Air and surface temperature must be between 50° and 90°F.</p> <p>Thinning not required.</p> <p>Brush—Use a nylon/polyester brush Roller—Use a 3/8" - 1/2" nap cover Spray—Airless Pressure 2000 psi Tip017" - .025"</p> <p><u>CLEANUP INFORMATION</u></p> <p>Clean spills and spatters immediately with soap and warm water.
