This Limited Warranty may be transferred by the Owner one (1) time during the first five (5) years of the Term to a Purchaser of the real estate upon which Deck Boards or Deck Boards and Deck Screws are installed. The transfer must be performed in accordance with the paragraph entitled "Transferability." No other transfers are permitted.

EverGrain® Envision™ and EverGrain® Envision™ Composite Deck Screw Limited Warranty

THIS LIMITED WARRANTY APPLIES ONLY TO DECK BOARDS OR DECK BOARDS AND DECK SCREWS INSTALLED IN THE UNITED STATES AND THE FOLLOWING CANADIAN PROVINCES: BRITISH COLUMBIA, ALBERTA, ONTARIO, SASKATCHEWAN, MANITOBA AND NEW BRUNSWICK. ALL PRODUCTS INSTALLED IN LOCATIONS WHERE THIS LIMITED WARRANTY DOES NOT APPLY ARE SOLD "AS IS" AND WITHOUT WARRANTY OF ANY KIND, INCLUDING ANY IMPLIED WARRANTY OR CONDITION OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

The Deck Screw portion of this Limited Warranty only applies to Deck Screws which are used to install TAMKO EverGrain® Envision™ Deck Boards

How Long Will The Deck Boards and Deck Screws Last: It is natural for the Deck Boards and Deck Screws to age. The process begins as soon as the Deck Boards and Deck Screws are installed and exposed to the harsh elements of nature. The length of time the Deck Boards and Deck Screws will continue to perform its intended purpose will depend on many factors, including weather, snow, intensity of ultra-violet radiation from the sun, pollution, debris, treatment and usage. Because no two buildings experience these and other aging factors in the same way, it is difficult to accurately predict the period of time a Deck Boards and Deck Screws will last. This Limited Warranty, subject to its terms and conditions, provides you a remedy in the event a manufacturing defect causes a Deck Boards to excessively degrade, split, check, splinter or be damaged by termites or if Deck Screws rust or corrode during the Term (as defined below). Determination of the suitability and safety of any particular use or application of the Deck Boards and Deck Screws is solely the responsibility of the Owner. Building code regulations vary from area to area. The Owner should consult local building and safety codes for specific requirements.

In this Limited Warranty certain capitalized words have specific meanings:

"**TAMKO**" means TAMKO Building Products, Inc.

"**Term**" means the period of time the Limited Warranty lasts. The Term begins on the date of Purchase and continues, unless sooner terminated, for the applicable period as listed in Table 1.

"**Deck Boards**" means TAMKO EVERGRAIN ENVISION Decking purchased from a TAMKO authorized dealer.

"**Deck Screws**" means TAMKO EVERGRAIN ENVISION Composite Deck Screws.

"**Owner**" means the owner of the real estate at the time the Deck Boards and Deck Screws are installed on that real estate. If you purchase a new residence and are the first person to occupy the residence, TAMKO will consider you to be the Owner if the Deck Boards and Deck Screws are installed as part of the construction of that residence.

"**Purchase**" means the retail purchase of the Deck Boards and Deck Screws.

"**Full Start Period**" means the initial period of the Term during which TAMKO's obligation is not prorated. The Full Start Period begins on the date of Purchase of the Deck Boards and Deck Screws and continues, unless sooner terminated, for the applicable period as listed in Table 1.

"**Maximum Obligation**" means the obligation of TAMKO described in the paragraphs titled "TAMKO Full Start Period", "After the Full Start Period," or "Deck Screw Limited Warranty", whichever is applicable.

Deck Board Limited Warranty

TAMKO Full Start Period: If, during the Full Start Period, Deck Boards that have been installed in strict accordance with the applicable application instructions (available at tamko.com or evergrain.com, or by calling 1-800-641-4691) are determined to have excessive degradation, split, checked, splintered or suffered termite damage as a direct result of a manufacturing defect, TAMKO will provide the Owner with the reasonable cost of replacement of Deck Boards determined to be defective and the reasonable cost of installing replacement Deck Boards (excluding removal or disposal of Products), according to the terms of this Limited Warranty. This is TAMKO's Maximum Liability during the Full Start Period.

After TAMKO's Full Start Period: If, after the end of the Full Start Period, Deck Boards that have been installed in strict accordance with the applicable application instructions (available at evergrain.com or tamko.com, or by calling 1-800-641-4691) are determined to have excessive degradation, split, checked, splintered or suffered termite damage as a direct result of a manufacturing defect, TAMKO's obligation is limited to providing the Owner with the reasonable cost of replacement Deck Boards for the Deck Boards determined to be defective (excluding removal or disposal of the original Deck Boards). The reasonable cost of the replacement Deck Boards will be prorated over the Term of this Limited Warranty. This is TAMKO's Maximum Liability after the end of the Full Start Period. TAMKO is not responsible for the cost of labor for installing the replacement materials after the end of the Full Start Period. Proration shall be determined by dividing the number of months remaining in the Term by the total number of months of the Term. For example, if TAMKO is notified of a warranty claim at a time when 80 months remain on the Term in a 240-month Term, TAMKO's Maximum obligation is to provide the reasonable cost for one-third of the replacement Deck Boards. The remaining cost shall be the responsibility of the Owner.

Deck Boards located in higher-traffic areas may show wear earlier than other areas. Dragging objects across the Deck Boards may cause surface scratches. Color variation occurs naturally in the manufacturing process and, as with natural lumber, should be expected. Surface wear, scratches, minor degradation and color variation are not defects and are not covered by this Limited Warranty.

TAMKO is not responsible for the cost of labor for installing replacement Deck Boards unless otherwise stated in this Limited Warranty. TAMKO is not responsible for the cost of any materials other than the replacement Deck Boards (as provided herein) including without limitation, substructure, supporting structure, fasteners, etc. TAMKO is not responsible for the cost of removing or disposing of Deck Boards which are to be replaced. Replacement Deck Boards will be warranted only for the remainder of the original Term. Tender of the payment for the reasonable cost of the applicable amount of replacement material and/or labor (if applicable) shall extinguish all liability of TAMKO under this Limited Warranty and all applicable implied warranties for such claim.

Deck Screw Limited Warranty

The Deck Screw Limited Warranty only applies to Deck Screws used to install TAMKO EverGrain Envision Decking.

If during the Term of the Limited Warranty, the Deck Screws that have been used to install EverGrain Envision Composite Deck Boards, in strict accordance with the applicable application instructions (available at tamko.com or evergrain.com, or by calling 1-800-641-4691), are determined to have rust or corrosion as a direct result of a manufacturing defect, TAMKO's obligation is limited to providing the Owner with a refund of the original purchase price of the Deck Screws determined to be defective. This is TAMKO's Maximum Obligation during the Term of the Limited Warranty.

TAMKO is not responsible for the cost of labor for installing replacement Deck Screws. TAMKO is not responsible under this Deck Screw Limited Warranty for the cost of the Deck Boards or any materials other than the replacement Deck Screws (as provided herein) including without limitation, substructure, supporting structure, decking material etc. TAMKO is not responsible for the cost of removing or disposing of Deck Screws or other materials which are to be replaced. Tender of payment of the original purchase price of the Deck Screws shall extinguish all liability of TAMKO under this Deck Screw Limited Warranty and all applicable implied warranties for such claim.

Notification to TAMKO: The Owner must notify TAMKO by certified mail at P.O. Box 1404; Joplin, Missouri 64802-1404 of any claims under this Limited Warranty within thirty (30) days following discovery. The notice must include documentary proof of Purchase. Failure of the Owner to notify TAMKO as provided herein shall extinguish all liability of TAMKO under this Limited Warranty and all applicable implied warranties.

Right of Inspection and Claim Processing: TAMKO shall have a reasonable time after notification to inspect the Deck Boards and Deck Screws. The Owner shall provide TAMKO with reasonable access to the Deck Boards and/or Deck Screws for purposes of inspection. If requested by TAMKO, the Owner must complete and deliver to TAMKO, at the Owner's expense, a warranty questionnaire, photographs of the Deck Boards and/or Deck Screws, proof of purchase of the Deck Boards and/or Deck Screws, an estimate to replace or repair the affected area, and samples of the Deck Boards and/or Deck Screws. If reasonable access is denied or made subject to unreasonable conditions by the Owner, or if the Owner fails or refuses to cooperate in TAMKO's investigation of the claim (such as by failing to provide sample Deck Boards and/or Deck Screws [if requested], proof of purchase, estimate, photographs or a completed warranty questionnaire), TAMKO's obligation under this Limited Warranty shall immediately terminate. If TAMKO determines there are manufacturing defects covered by this Limited Warranty, TAMKO will have up to ninety (90) days after receipt of notification to process the Owner's claim.

20-Year Stain Resistance Limited Warranty: EverGrain Envision is also covered by a 20-year Stain Resistance Limited Warranty. The Deck Boards are resistant to permanent staining from spills of food and beverage items including mustard, ketchup, barbecue sauce, canola oil, tea, coffee, wine, fruit punch and sodas, so long as such substances are promptly removed from the Deck Boards in accordance with TAMKO's written care and cleaning instructions for Deck Boards and are not rubbed into the Deck Boards and the spill has not also contacted another material causing a chemical reaction. TAMKO does not warrant the Deck Boards to be stain proof, and does not warranty stain resistance resulting from spilled or otherwise applied food and beverage substances which are not properly and promptly cleaned as provided in TAMKO's written care and cleaning instructions or which have been rubbed into the Deck Boards. The Limited Warranty does not cover any staining or damage to the Deck Boards caused by abrasive compounds of

acidic or basic pH, mold/mildew, paints or stains, solvents, metallic rust, and non-food and non-beverage substances, including, but not limited to, biocides, fungicides, insect repellent/insecticides, plant foods or bactericides, motor oil and suntan/sunscreen lotion.

Claims Regarding Stain Resistance: If the Owner is making a claim relating to the Limited Warranty on stain resistance, the Owner must do all the following (in addition to the procedures set forth in the Right of Inspection and Claim Processing section):

1. Attempt to clean the affected area of the Deck Boards by using the cleaning procedures described in TAMKO's written care and cleaning instructions promptly after the exposure of the food or beverage to the surface of the Deck Boards.
2. If, after completing step one (1) above, the affected area remains unreasonably visible, then the Owner must have the affected area of the Deck Boards cleaned by a professional deck cleaner at the Owner's expense within one (1) week of the exposure of the food or beverage to the surface of the Deck Boards.
3. If, after completing steps 1 and 2 above, the affected area still remains unreasonably visible, the Owner may make a claim under this Limited Warranty as provided herein, provided that such claim is made within thirty (30) days after the professional cleaning is completed.

Exclusions from Coverage: TAMKO shall not be liable under any circumstance for:

1. Deck Boards or Deck Screws, not installed in strict accordance with TAMKO's written application instructions, or damages resulting from such installation.
2. Use of Deck Boards or Deck Screws in applications not permitted by applicable building codes.
3. Damage to any building or supporting structure, either exterior or interior, or any property contained therein or for injuries or damages of any kind whatsoever.
4. The cost of removal, reinstallation or disposal of any Deck Boards or Deck Screws, or for any costs associated with such, including labor, freight or taxes, unless otherwise stated in this Limited Warranty.
5. Variations in uniformity of color, variations or natural changes in color, weathering, color fading and natural efflorescence are not covered unless otherwise stated in this Limited Warranty.
6. Staining or discoloration due to foreign substances not covered in the "20-Year Stain Resistance Limited Warranty" including, but not limited to, food or beverages not promptly and properly cleaned, rubbed in food stains, stains caused by interactions with another item, such as metal furniture, stains not covered under this Limited Warranty or chemicals found in cleaners not approved for use in TAMKO's written care and cleaning instructions for Deck Boards or Deck Screws.
7. Environmental conditions including, but not limited to, air pollution, mold and mildew.
8. Damages resulting from Acts of God (including, but without limitation, lightning, wind, hurricane, tornado, hail, flooding or other violent storm or casualty).
9. Damage to Deck Boards or Deck Screws caused by movement, distortion, collapse or settling of the ground, building or supporting structure.
10. Damage caused by improper handling, shipment and/or storage of the Deck Boards or Deck Screws.
11. Damage caused by neglect, abuse, misuse or improper upkeep and maintenance.
12. Damage caused by factors that are beyond the reasonable control of TAMKO.

The serviceable life of the Deck Boards or Deck Screws is affected by several factors, such as quality of installation, maintenance and normal wear and tear. These are all factors beyond TAMKO's reasonable control and for which TAMKO makes no warranty.

Transferability: The Owner may transfer this Limited Warranty one (1) time during the first five (5) years of the Term to a purchaser of the real estate upon which the Deck Boards and Deck Screws are installed (a "Purchaser"). The transfer must occur simultaneously with the sale of the real estate. To transfer this Limited Warranty, the Owner must provide TAMKO with written notice within thirty (30) days after the transfer. The written notice must include the names of the Owner and the Purchaser, the address of the real estate upon which the Deck Boards and Deck Screws are installed, the date the Deck Boards and Deck Screws were installed, and the date of the transfer. The Owner may transfer this Limited Warranty only one (1) time. Except for one transfer to a Purchaser during the first five (5) years of the Term, this Limited Warranty may not be sold, assigned or transferred in any manner whatsoever. Neither a Purchaser nor any other person may transfer this Limited Warranty. Except as set forth in this paragraph, any assignment, sale or transfer of this Limited Warranty or the real estate on which the Deck Boards and Deck Screws are installed shall immediately terminate all liability of TAMKO, all warranties contained herein or hereunder and any applicable implied warranties, including warranties of merchantability and fitness for a particular purpose.

MANDATORY BINDING ARBITRATION: EVERY CLAIM, CONTROVERSY OR DISPUTE OF ANY KIND WHATSOEVER, INCLUDING WHETHER ANY PARTICULAR MATTER IS SUBJECT TO ARBITRATION (EACH AN "ACTION") BETWEEN YOU AND TAMKO (INCLUDING ANY OF TAMKO'S EMPLOYEES AND AGENTS) RELATING TO OR ARISING OUT OF THE DECK BOARDS OR DECK SCREWS, SHALL BE RESOLVED BY FINAL AND BINDING ARBITRATION, REGARDLESS OF WHETHER THE ACTION SOUNDS IN WARRANTY, CONTRACT, STATUTE OR ANY OTHER LEGAL OR EQUITABLE THEORY. TO ARBITRATE AN ACTION AGAINST TAMKO, YOU MUST INITIATE THE ARBITRATION IN ACCORDANCE WITH THE APPLICABLE RULES OF ARBITRATION OF THE AMERICAN ARBITRATION ASSOCIATION (WHICH ARE AVAILABLE ONLINE AT www.adr.org OR BY CALLING THE AMERICAN ARBITRATION ASSOCIATION AT 1-800-778-7879), THE JUDICIAL ARBITRATION AND MEDIATION

SERVICE OR OTHER ARBITRATION SERVICE AGREED TO IN WRITING BY TAMKO, AND PROVIDE WRITTEN NOTICE TO TAMKO BY CERTIFIED MAIL AT P.O. BOX 1404, JOPLIN, MISSOURI 64802-1404 WITHIN THE TIME PERIOD PRESCRIBED BELOW.

ANY ACTION BROUGHT BY YOU AGAINST TAMKO WILL BE ARBITRATED (OR, IF ARBITRATION OF THE ACTION IS NOT PERMITTED BY LAW, LITIGATED) INDIVIDUALLY AND YOU WILL NOT CONSOLIDATE, OR SEEK CLASS TREATMENT FOR, ANY ACTION UNLESS PREVIOUSLY AGREED TO IN WRITING BY BOTH TAMKO AND YOU.

LEGAL REMEDIES: REMEDIES FOR BREACH OF THIS LIMITED WARRANTY OR ANY IMPLIED WARRANTY ARE EXCLUSIVE AND REPRESENT THE SOLE REMEDIES AVAILABLE TO THE OWNER OR ANY OTHER PERSON OR ENTITY, INCLUDING ANY MORTGAGEE, INSURER, OR OTHER PARTY IN INTEREST. OBLIGATIONS CONTAINED IN THIS LIMITED WARRANTY ARE EXPRESSLY IN LIEU OF ANY OTHER OBLIGATIONS, GUARANTEES, WARRANTIES, AND CONDITIONS EXPRESSED OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY OR CONDITION OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND OF ANY OTHER OBLIGATIONS OR LIABILITY ON THE PART OF TAMKO BUILDING PRODUCTS, INC. IN NO EVENT SHALL TAMKO BE LIABLE FOR DIRECT OR INDIRECT ECONOMIC DAMAGES, OR FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES OF ANY KIND, INCLUDING BUT NOT LIMITED TO PERSONAL INJURY (WHETHER TO THE PURCHASER, OWNER OR THIRD PARTIES), PROPERTY DAMAGE AND/OR LOSS OF BUSINESS OR PROFIT.

SOME STATES AND PROVINCES DO NOT ALLOW EXCLUSION OR LIMITATION OF IMPLIED WARRANTIES OR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY TO YOU. THIS LIMITED WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE AND PROVINCE TO PROVINCE. INVALIDITY OR UNENFORCEABILITY OF ANY PROVISION HEREIN SHALL NOT AFFECT THE VALIDITY OR ENFORCEABILITY OF ANY OTHER PROVISION WHICH SHALL REMAIN IN FULL FORCE AND EFFECT.

ONE YEAR STATUTE OF LIMITATIONS. NO ACTION FOR BREACH OF THIS LIMITED WARRANTY OR ANY OTHER ACTION AGAINST TAMKO RELATING TO OR ARISING OUT OF THE DECK BOARDS OR DECK SCREWS, THEIR PURCHASE OR THIS TRANSACTION SHALL BE BROUGHT LATER THAN ONE YEAR AFTER ANY CAUSE OF ACTION HAS ACCRUED. IN JURISDICTIONS WHERE STATUTORY CLAIMS OR IMPLIED WARRANTIES AND CONDITIONS CANNOT BE EXCLUDED, ALL SUCH STATUTORY CLAIMS, IMPLIED WARRANTIES AND CONDITIONS AND ALL RIGHTS TO BRING ACTIONS FOR BREACH THEREOF EXPIRE ONE YEAR (OR SUCH LONGER PERIOD OF TIME IF MANDATED BY APPLICABLE LAWS) AFTER THE DATE OF PURCHASE. SOME STATES AND PROVINCES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY OR CONDITION LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

NO REPRESENTATIVE, EMPLOYEE OR OTHER AGENT OF TAMKO, OR ANY PERSON OTHER THAN TAMKO'S PRESIDENT, HAS AUTHORITY TO ASSUME FOR TAMKO ANY ADDITIONAL LIABILITY OR RESPONSIBILITY IN CONNECTION WITH THE DECK BOARDS OR DECK SCREWS EXCEPT AS DESCRIBED HEREIN.

IF YOU ARE NOT SATISFIED WITH THE TERMS AND CONDITIONS OF THIS LIMITED WARRANTY, RETURN ALL UNINSTALLED MARKETABLE DECK BOARDS AND DECK SCREWS TO THE TAMKO AUTHORIZED DEALER WHO ORIGINALLY SOLD YOU THE PRODUCTS FOR A REFUND ON THE RETURNED DECK BOARDS OR DECK SCREWS.

THIS LIMITED WARRANTY APPLIES TO DECK BOARDS AND DECK SCREWS PURCHASED ON OR AFTER SEPTEMBER 17, 2012, AND SUPERSEDES ALL PREVIOUSLY PUBLISHED WARRANTIES. THIS FORM IS NOT TO BE COPIED OR REPRODUCED IN ANY MANNER.

The terms and conditions of the Limited Warranty offered by TAMKO for the Deck Boards and Deck Screws may change periodically. The Limited Warranty set forth above was the Limited Warranty offered by TAMKO at the date of printing. **ONLY the Limited Warranty OFFERED by TAMKO at the time of YOUR purchase of the Deck Boards and Deck Screws shall apply to your Deck Boards and Deck Screws. Consult TAMKO's website at www.TAMKO.com for current Limited Warranty information on the Deck Boards and Deck Screws.**
