




# 3M<sup>™</sup> FireDam<sup>™</sup> 2000 Coating






Remove lid from pail. If necessary, stir 3M<sup>™</sup> FireDam<sup>™</sup> 2000 Coating. Dilute with water to adjust viscosity for spray applications.



Ensure areas to be coated are clean and dry.



\*Allow 2–8 hours of drying time depending on thickness of coating, humidity and temperature.

Apply coating with brush, trowel or spray as desired to a minimum of 3mm wet thickness.\*



#### **Installation Guide**

This installation guide highlights requirements for 3M<sup>™</sup> FireDam<sup>™</sup> 2000 Coating for firestopping general through-penetration applications. This guide is intended only to highlight general steps or methods and is not intended to describe all details and requirements. System specifications should comply with local and federal regulations. Installer should confirm that the field conditions (such as opening size, pipe size and material, insulation type and thickness, and annular space) comply with the system specifications.
