



## BRIDGE-DEK Data Sheet

**COMPLIANCE:** Exceeds performance requirements of ASTM D 517. A.R.E.M.A. Specifications, Chapter 29 for Membrane Waterproofing.

**DESCRIPTION:** APOC® 5720 BRIDGE-DEK asphalt planks are used and approved by leading railroad companies throughout the United States, to protect the waterproofing membranes on railroad bridges. They are a tough, durable, protective cover designed to protect the various membrane waterproofing systems found on railroad bridges. While not intended as a waterproofing membrane APOC® BRIDGE-DEK planks consist of a core of air blown asphalt and mineral fiber which is covered on both sides with a flexible inorganic fiberglass mat. The result is a moldable, water repellent panel that will not shrink or decay.


PREPARATION: Sweep surface free of debris, dirt and dust.

**APPLICATION:** For exterior use only. Adhesives approved by the membrane manufacturer may also be used to hold the panels in place. Cover the total surface of the membrane by tightly fitting all edges. Use a sharp utility knife to cut planks to smaller sizes.


**PRECAUTIONS:** Do not use APOC® 501 or APOC® 502 as an adhesive. Do not apply Protection Panel over uncured solvent based membranes. Wait till membrane is completely cured. Caution should be used during backfill operations to avoid puncturing the membrane or dragging the plank across the surface.
