# **PRODUCT USES**

Bostik Grout Sealant & Colorant $^{\rm TM}$  is designed to be applied over sanded and unsanded cement based grouts to renew or change the color of the grout.

# **DIRECTIONS FOR USE**

Read and understand technical and safety data sheets completely before beginning installation. Follow applicable industry installation standards. Refer to www.bostik.com/us for the most recent product information and safety data sheet prior to installation. Refer to TCNA handbook for grout installation guidelines.

#### **SURFACE PREPARATION**

Grout must be free of alkali, paint, wax, sealer and other contaminants prior to application. Test in an inconspicuous area first.

#### **APPLICATION**

Shake well. Do not thin or dilute product. If more than one bottle is needed mix bottles together to avoid any color variance. Apply product onto the grout joint with a paint brush, lightly



working it into the surface of the grout. Immediately wipe excess product from tile surfaces with a damp chamois cloth. Apply in a uniform coat.

#### **COVERAGE**:

1/4 in 12x12 tile is 300 sq ft of tile

#### **CLEAN-UP**

Clean from tile with a damp chamois cloth. Clean brush with soap and water. Do not allow material to dry on surface of tile.

#### CURING

Ready for light traffic in 2 to 4 hours, normal traffic in 24 hours. Avoid washing for 72 hours.
