Who and What Are Covered and for How Long

CertainTeed Corporation (CertainTeed) warrants that the products listed below will be free from manufacturing defects if installed according to our applicable installation instructions and subject to the terms, conditions and limitations of this limited warranty.

For Lifetime Limited Warranty Products, Residential:

The limited warranty remains in effect for the lifetime of the original homeowner as long as the original homeowner retains ownership of the property in which the product was installed. The lifetime warranty is available only to homeowners residing in individual residences, including multi-family properties, condominiums and cooperatives, where the product is installed.

For One-Year Limited Warranty Products, Non-Residential Uses:

For insulation installed in non-residential or commercial buildings, the limited warranty is effective for one (1) year from the date of installation.

Transferability

For Lifetime Limited Warranty Products, Residential:

In the event the original homeowner sells or transfers the residence in which the product was installed, the coverage provided by this limited warranty will be transferred to the first subsequent homeowner and will be limited in duration to twenty (20) years from the date of the original installation of the product.

For One Year Limited Warranty Products, Non-Residential Uses:

The coverage under this limited warranty is not transferable.

What the Customer Must Do

To obtain performance under this limited warranty, the original homeowner (or the first subsequent property owner), installation contractor or supplier must notify CertainTeed in writing of any claimed defect promptly following its discovery and must submit with such notice, proof of date of purchase and installation in order to provide CertainTeed an opportunity to investigate the claim and examine the product claimed to be defective. Notification must be provided to CertainTeed Corporation, 20 Moores Road, Malvern, PA 19355, Attention: IG Technical Services Department. CertainTeed will inspect the claimed defect and if such examination does disclose a defect covered by this limited warranty, CertainTeed either will repair or replace the defective product subject to the terms set forth above.

Limitations

This Limited Warranty does not provide protection against, and CertainTeed will have no liability for, any failure, defect or damage caused by events beyond its control, including but not limited to:

- Lightning, hailstorm, tornado, hurricanes, acts of God, earthquake, fire, explosion, flood or falling objects
- Adhesives, paints, coatings, biocides, encapsulants or other chemicals
- Material adjacent to the insulation
- Distortion, cracking or other failure or movement of the walls, duct work or foundation of the building
- Structural changes, alterations or additions, or by the installation of equipment to the building after the insulation was installed
- Misuse, abuse, neglect or improper transportation, handling or storage of the insulation
- Improper installation or installation not in accordance with CertainTeed's installation instructions published at the time of original installation
- Impact, including such things as tools or equipment
- Vandalism or acts of war
- Animals or insects
- Any other cause not a result of a manufacturing defect in the Insulation

CertainTeed reserves the right to discontinue or modify any of its products and shall not be liable as a result of such discontinuance or modification, nor shall CertainTeed be liable in the event replacement material varies in comparison to the original product. If CertainTeed replaces any material under this warranty, it may substitute products designated by CertainTeed to be of comparable quality or price range in the event the product initially installed has been discontinued or modified.
