- Allowable moment includes cold work of forming.
- Allowable moment is taken as the lowest value based on local or distortional buckling. Distortional buckling strength is based on a k-phi = 0.
- Web depth for track sections is equal to the nominal height plus two times the design thickness plus the bend radius. Hems on nonstructural track sections are ignored.

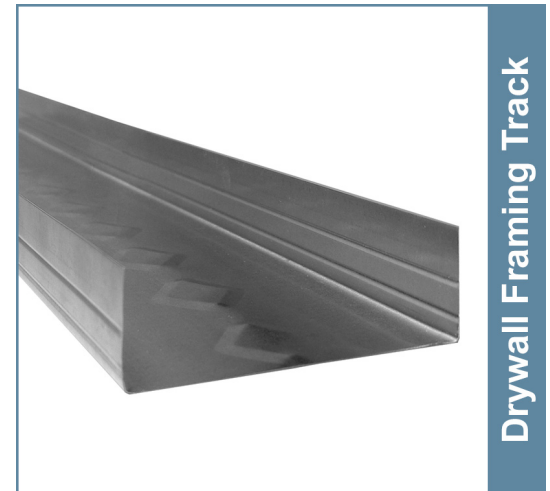
