# 4. First-aid Measures

# 10. Stability and Reactivity

STABILITY: Stable under recommended storage conditions.

# **11.** Toxicological Information

There have been cases of aplastic anemia from toluene in industrial exposures (ACGIH, 1992). Increased coagulation time and reduced clotting factors have also been found, which are indicators of damage to the bone marrow (Clayton & Clayton, 1994). Symptoms include: loss of memory, loss of intellectual ability and loss of coordination.
