## **Description**

DOWSIL™ IE-2404 Emulsion is a 50% active non-ionic silicone resin emulsion. It is used as a binder in silicone-resin-based render and coating formulations to provide high moisture-vapor permeability, good liquid water repellency, and high UV resistance when formulated properly. Typically, DOWSIL™ IE-2404 Emulsion is used in conjunction with additional acrylic-based binders.

As a reactive silicone resin, active ingredients from DOWSIL™ IE-2404 Emulsion can chemically react with fillers and pigments.

Silicone resins are well known for their ability to reinforce and bind inorganic materials. This leads to protection of the hydrophilic pigments or fillers from water intrusion in the film.

#### How to Use

DOWSIL™ IE-2404 Emulsion can be diluted in water before use or can be used as supplied. The water should be added to the emulsion. Deionized water is recommended for dilution. To prevent mold growth within the package, additional preservatives may be required.

For best performance, use levels of DOWSIL™ IE-2404 Emulsion contents are recommended at 3–8% for render applications and 6–10% for coating applications.

Beading and water repellency for liquid water can be further improved by the addition of a small amount of DOWSIL™ Z70 Emulsion.
