3. The manufacturer shall provide clearly written application instruction.
4. Exposure and course layout shall be in compliance with Detail "A", attached.
5. Nailing shall be in compliance with Detail "B", attached.

Shingles shall bear the imprint or identifiable marking of the manufacturer's name or logo, city and state of manufacturing facility, and following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.

DETAIL A COURSE LAYOUT

**SHINGLE
INSTALLATION**

Start at either rake and lay in either direction

First Course:

Start with full shingle.
Trim $\frac{1}{2}$ " (3mm) notch.

Second Course:

Trim 5" (127mm) off first shingle

Third Course:

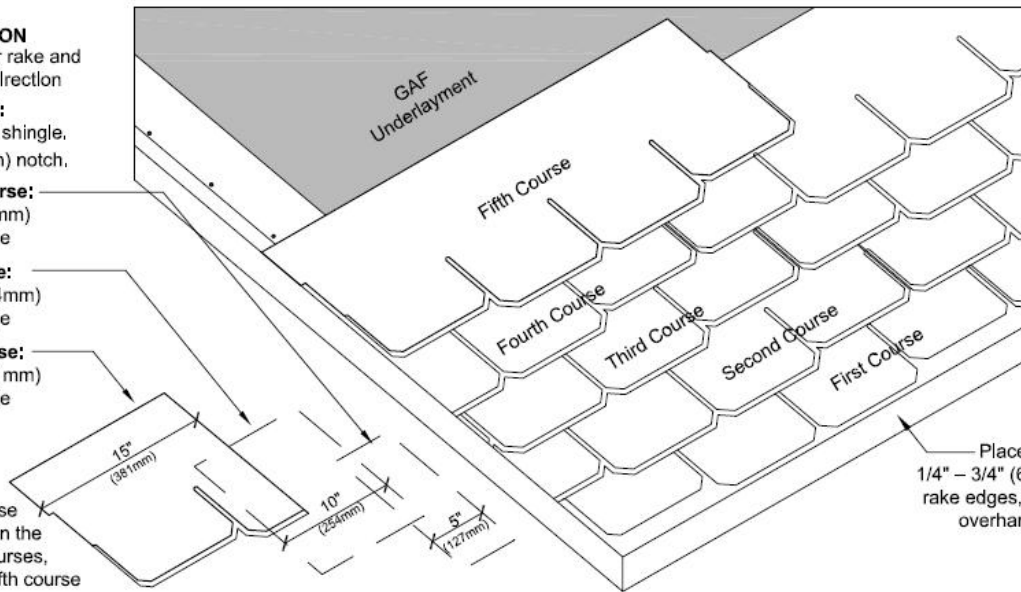
Trim 10" (254mm) off first shingle

Fourth Course:

Trim 15" (381mm) off first shingle

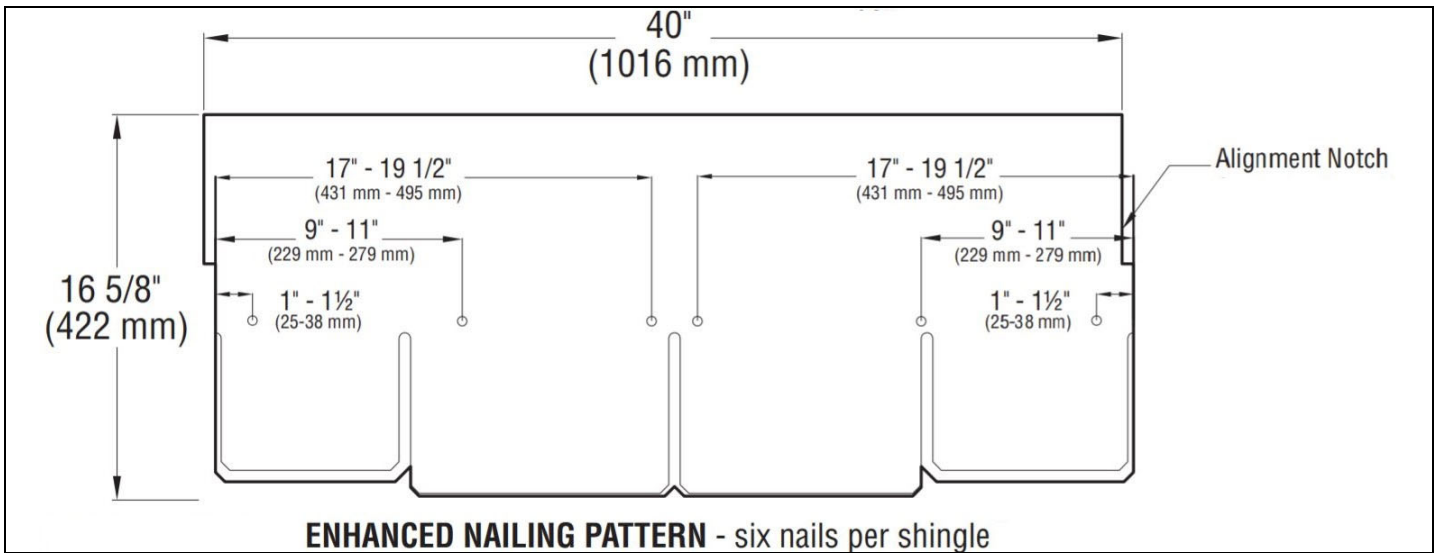
Remaining Courses:

Repeat the 1st - 4th course instructions on the remaining courses, starting the fifth course



Place first course of shingles $\frac{1}{4}$ " - $\frac{3}{4}$ " (6-19mm) over eave and rake edges, covering starter course overhang, to provide drip edge.
