SUBSTANCE NOTES: Gypsum (calcium sulfate dihydrate) contains naturally occurring crystalline silica as an impurity, generally of the quartz form. As further indicated in Section 11 of Georgia-Pacific's Paper Faced Gypsum Panels SDS (<https://sds.gp.com/>), exposure to respirable crystalline silica from occupational sources is listed by IARC and NTP as a lung carcinogen. Testing conducted by Georgia-Pacific and other gypsum wallboard manufacturers using generally accepted industrial hygiene practices with both personal and area sampling did not detect respirable crystalline silica during activities associated with normal use of this product (i.e., cutting the product by "score and snap", hand saw or rotary saw).
