### 4. FIRST AID MEASURES

**Description of first aid measures****General advice**

In case of accident or unwellness, seek medical advice immediately (show directions for use or safety data sheet if possible). If symptoms persist, call a physician.

**Eye contact**

Keep eye wide open while rinsing. Immediately flush with plenty of water. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. If symptoms persist, call a physician.

**Carcinogenicity**

An analysis of cancer studies in humans suggests an association between lung cancer and exposure to hard bitumens during roofing and mastic asphalt work. The majority of animal studies of oxidized asphalt have been negative in dermal cancer studies, however a two-year study in mice exposed to fume condensates of severely oxidized asphalt caused a weak, but statistically significant increase in skin tumors. The International Agency for Research on Cancer (IARC) published a preliminary finding in late 2011 indicating that occupational exposures to asphalts and their emissions during roofing and mastic asphalt work present a potential cancer risk to humans.
