PRODUCT DESCRIPTION: Henry DB50 and DB100 are water retention and drainage composites. These composites consist of a high-strength dimpled water-retention polymeric core laminated with a topsoil filter fabric and bottom protection fabric. The bottom fabric layer provides cushioning properties, offering protection to the underlying waterproofing membrane. Cups or 'dimples' in the core offer water storage capacity for vegetation layer between rain events, with overflow drainage once the 'dimple' storage capacity is reached.
