Description

HE193 - DOT STICK is a hot melt adhesive used to securely bond pavement markers to asphaltic concrete and portland cement concrete roadways.

Coverage

4 - 6 markes per pound of Dot Stick

Surface Preparation

Pavement surface should be dry and free from all loose material, dirt and dust.

Application

The material should be heated in a temperature controlled melter with an agitation system. The adhesive should be dispensed at the desired intervals at an application temperature of $400 - 415^{\circ}F$ (204 - $213^{\circ}C$). The marker should be installed and pressed into the adhesive immediately. The pavement surface should be clean and dry prior to application. The pavement temperature should be at least $50^{\circ}F$ for proper application.

Cleanup

Asphaltic stains can be removed with non-hazardous, biodegradable cleaners. Use waterless hand cleaner on skin.

CAUTION! Keep boxes out of direct sunlight and rain. If covered area is not accessible, cover with tarp. Do not take internally.
