### **SECTION 4: FIRST AID MEASURES**

#### 4.1. Description of First-aid Measures

#### 4.2. Most Important Symptoms and Effects Both Acute and Delayed

**General:** May cause respiratory irritation. Skin sensitization. May cause cancer by inhalation. Causes damage to organs (lung/respiratory system) through prolonged or repeated exposure (Inhalation). Causes skin irritation. Causes serious eye damage. **Inhalation:** Irritation of the respiratory tract and the other mucous membranes. Some studies show that exposure to respirable crystalline silica (without silicosis) or that the disease silicosis may be associated with the increased incidence of several autoimmune disorders such as scleroderma (thickening of the skin), systemic lupus erythematosus, rheumatoid arthritis and diseases affecting the kidneys. Silicosis increases the risk of tuberculosis. Some studies show an increased incidence of chronic kidney disease and end-stage renal disease in workers exposed to respirable crystalline silica.

**Skin Contact:** May cause an allergic skin reaction. Redness, pain, swelling, itching, burning, dryness, and dermatitis. Repeated exposure may cause skin dryness or cracking.

**Eye Contact:** Causes permanent damage to the cornea, iris, or conjunctiva. Concrete may cause immediate or delayed irritation or inflammation. Eye contact with wet concrete can cause moderate eye irritation, chemical burns and blindness. Eye exposures require immediate first aid and medical attention to prevent significant damage to the eye.

Ingestion: Ingestion may cause adverse effects.

**Chronic Symptoms:** Long term exposure to respirable crystalline silica results in a significant risk of developing silicosis and other non-malignant respiratory disease, lung cancer, kidney effects, and immune system effects.

#### 4.3. Indication of Any Immediate Medical Attention and Special Treatment Needed

If exposed or concerned, get medical advice and attention. If medical advice is needed, have product container or label at hand.

## SECTION 5: FIRE-FIGHTING MEASURES

### 5.1. Extinguishing Media

Suitable Extinguishing Media: Water spray, dry chemical, foam, carbon dioxide.

### **SECTION 6: ACCIDENTAL RELEASE MEASURES**

### SECTION 7: HANDLING AND STORAGE

#### 7.1. Precautions for Safe Handling

Additional Hazards When Processed: Cutting, crushing or grinding crystalline silica-bearing materials may release respirable crystalline silica, a known carcinogen. Use all appropriate measures of dust control or suppression and Personal Protective. Heavy material- proper lifting methods or equipment.

**Precautions for Safe Handling:** Obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Wash hands and other exposed areas with mild soap and water before eating, drinking or smoking and when leaving work. Do not get in eyes, on skin, or on clothing. Do not breathe dust.

Hygiene Measures: Handle in accordance with good industrial hygiene and safety procedures.

#### 7.2. Conditions for Safe Storage, Including Any Incompatibilities

Technical Measures: Comply with applicable regulations.

**Storage Conditions:** Keep container closed when not in use. Store in a dry, cool place. Keep/Store away from direct sunlight, extremely high or low temperatures and incompatible materials. Store locked up/in a secure area.

**Incompatible Materials:** Acids, ammonium salts and aluminum metal. Cement dissolves in hydrofluoric acid, producing corrosive silicon tetrafluoride gas. Cement reacts with water to form silicates and calcium hydroxide. Silicates react with powerful oxidizers such as fluorine, boron trifluoride, chlorine trifluoride, manganese trifluoride, and oxygen difluoride.
