### Description

Driwall<sup>™</sup> Membrane Mastic is an asbestos free rubberized asphalt-based cement. Formulated to meet Federal specification SS-C-153C and ASTM D4586, Driwall Membrane Mastic can be used under wet or dry conditions, and may be used on horizontal or vertical surfaces. Engineered to have outstanding performance with all Keene Driwall Membrane products, Driwall Membrane Mastic will also work with most asphalt based waterproofing membranes.

#### **Application**

Suitable for any Driwall Membrane application Usable in both wet or dry conditions Acceptable for vertical or horizontal surfaces Appropriate for use over a wide variety of substrates

Ensure all surfaces are dry and free of any oil or grease. All surfaces must be clean and free of dust, dirt and any foreign material. Flashing – apply <sup>1</sup>/<sub>8</sub>" to <sup>1</sup>/<sub>2</sub>" thick around and over joints of flashing. Trowel down to a smooth, feathered edge. Small Holes (under 1") – trowel into, over and around hole about <sup>3</sup>/<sub>8</sub>" to <sup>1</sup>/<sub>2</sub>" thick, feather to edge. Large Holes – apply <sup>1</sup>/<sub>4</sub>" thick layer into and around the hole. Imbed a piece of membrane approximately 4" in diameter. Apply a layer of mastic over the patch feathering the edge. Wet conditions – work back and for the over surface to ensure maximum bond.
