R-value shall be determined by the prescriptive criteria established by the International Energy Conservation Code (IECC) standard in effect at the start of the year that is two years prior to the year the materials or systems are placed in service. The insulation and air sealing portion of the credit is only for principal residences located in the United States owned and used by the taxpayer (see Treasury Reg. § 1.121-1(B) for further details. Credit for qualifying expenditures incurred for existing home or for addition to or renovation of an existing home, and not for new construction.
