DESCRIPTION

UltraCare Abrasive Surface Cleaner is a powerful, abrasive cleaner that is safe for use on a variety of ceramic, porcelain and natural-stone surfaces. This water-based, biodegradable formula is nontoxic and nonflammable, containing no VOCs or acids. Cleaning does not require letting the product stand on the surface. *UltraCare* Abrasive Surface Cleaner penetrates deep into dense surface pores and easily removes ground-in dirt, grime, rust stains and mineral deposits. This product is formulated to remove most factory-applied waxes and floor finishes as well as light cementitious and epoxy grout residue. It is excellent for use on heavily textured and hard-to-clean surfaces. Plus, it can be used in combination with any *UltraCare* cleaner or problem-solver.

WHERE TO USE

- Can be used on natural stone; grouts; ceramic, porcelain, terra cotta, Saltillo, quarry and metallic tiles; terrazzo; concrete; pavers; and masonry. *UltraCare* Abrasive Surface Cleaner does not affect existing penetrating sealers. It will not scratch or etch most polished surfaces. This product can also be used in combination with any cleaner or problem-solver in MAPEI's *UltraCare* line of products.

LIMITATIONS

- Ensure that product does not come in contact with any non-recommended surface.
- Before using on polished marble, limestone or metallic tiles, apply in an inconspicuous area to ensure against scratching of these sensitive tile types.

Consult MAPEI's Technical Services Department for application recommendations regarding substrates and conditions not listed.

PRODUCT APPLICATION

Before product use, take appropriate safety precautions. Refer to the Safety Data Sheet for details.

Always test first in several inconspicuous areas to confirm desired results.

When used directly as a cleaner

1. Shake container vigorously for 1 minute before using.
2. Sweep, vacuum or wipe surface.
3. Pre-wet a small, manageable area with clean water.
4. Apply *UltraCare* Abrasive Surface Cleaner as needed to the pre-wet surface.
5. Scrub the surface with a white nylon pad, scrub brush or scrub machine.
6. Remove the dirty solution with a wet vac, mop, sponge or cloth.
7. Rinse thoroughly with clean water.
8. Repeat the process as necessary.

When used in combination with other cleaners

1. Follow steps 1 through 3 above.

2. Dilute the selected cleaner or problem-solver per that product's label instructions.
3. Carefully apply the solution to wet surface with a sponge or mop.
4. Allow selected cleaner or problem-solver to stand on the surface per label instructions.
5. Add *UltraCare* Abrasive Surface Cleaner to the pre-wet surface.
6. Scrub the surface with a white nylon pad, scrub brush or scrub machine.
7. Remove the dirty solution with a wet vac, mop, sponge or cloth.
8. Rinse thoroughly with clean water.
9. Repeat the process as necessary.

Close container tightly after each use. Store in original container only. Store between temperatures of 35°F and 90°F (2°C and 32°C).
