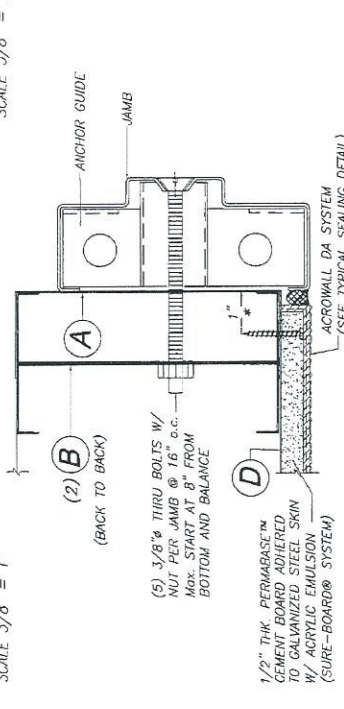
**SECTION A: WINDOW HEAD CONNECTION TO PANEL**

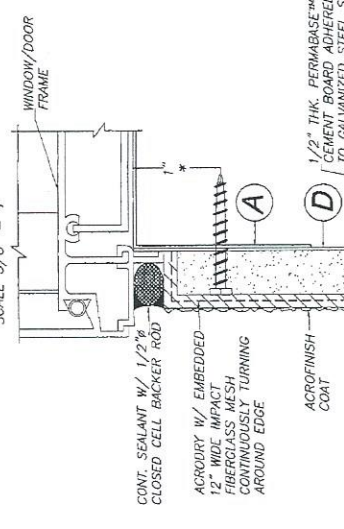

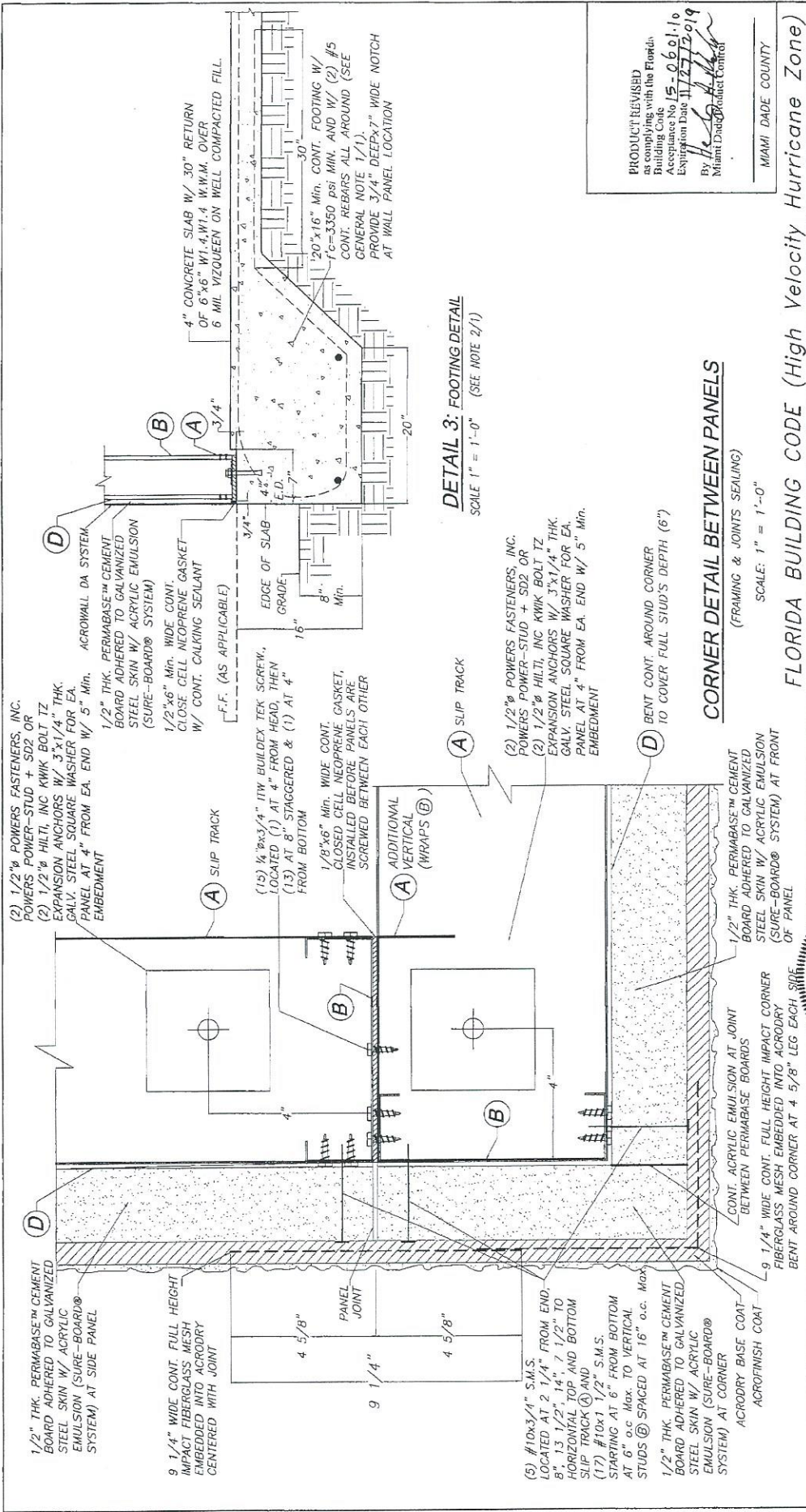
