Limited Warranty on Hip & Ridge Shingle Products

Limitations on the transferability of this warranty are set forth herein.

Introduction

Thank you for your recent purchase of Owens Corning Roofing and Asphalt, LLC (Owens Corning) Hip & Ridge shingle product. We believe we sell the highest quality and most attractive roofing products and systems available anywhere, and that is why we stand behind them with one of the best warranties in the industry. We have attempted to write this warranty in clear, plain-English terms, including the limitations and restrictions, so you will fully understand the warranty we are making to you. However, the terms contained herein are subject to change without notice. Who is Covered

To be eligible for this limited warranty, your property must be located in the United States or Canada and you must be the original consumer purchaser (i.e., the property owner, not the installer or contractor), or the first transferee from the original consumer purchaser (Owner) of one of our Owens Corning® Hip & Ridge shingle products listed at the end of this warranty, you are entitled to the benefits of this warranty.

What Is Covered

We warrant that your Owens Corning® Hip & Ridge shingle products are free from any manufacturing defects which materially affect their performance on your roof during the applicable warranty period.

How Long Are You Covered

If you've installed Owens Corning® Hip & Ridge shingle products with Owens Corning® Roofing Shingles: The length of the warranty depends on the type of Owens Corning® shingles installed on your property. See the chart at the end of this warranty for the specific warranty period that applies to your shingles installed. **If the only Owens Corning® Roofing product** installed is Owens Corning® Hip & Ridge shingles (not in conjunction with Owens Corning® shingles), we warrant that your Owens Corning® Hip & Ridge shingle product is free from manufacturing defects when manufactured. Owens Corning shall have no liability for any product failures and/or damage caused by improper installation or any other cause other than manufacturing defects. Should the product prove to be other than as warranted, Owens Corning's sole and exclusive liability shall be limited as described within the **Compensation** section herein.

▪ What About Wind Resistance

Your Owens Corning® Hip & Ridge shingle products contain asphalt sealant that requires direct warm sunlight for several days (Thermal Sealing) in order to seal properly. If your Owens Corning® Hip & Ridge shingle products are installed during a period of cool weather, they may not adequately seal until the season changes or the weather warms, and if your Owens Corning® Hip & Ridge shingle products never receive direct sunlight or are not exposed to adequate surface temperatures, they may never achieve Thermal Sealing. Prior to Thermal Sealing, your Owens Corning® Hip & Ridge shingle products are more vulnerable to blow-offs and wind damage. This is the fundamental nature of hip & ridge shingles and not a manufacturing defect, and we are not responsible for any blow-offs or wind damage that may occur prior to Thermal Sealing having occurred. After your Owens Corning® Hip & Ridge shingle products have achieved Thermal Sealing, however, they will be covered under this warranty if they experience blow-offs or wind

damage in winds up to the levels listed in the chart at the end of this warranty. HOWEVER, THE COVERAGE AGAINST SHINGLE BLOW-OFFS OR WIND DAMAGE IS IN EFFECT FOR A PERIOD OF FIFTEEN (15) YEARS, FROM THE ORIGINAL DATE OF INSTALLATION. Owens Corning will be liable only for the reasonable cost of replacing blown-off Owens Corning® Hip & Ridge Shingle product if applicable (to include material and labor during the applicable warranty period) and the reasonable cost of manually sealing the unsealed Owens Corning® Hip & Ridge shingle products remaining on the roof. Please refer to the **"Transferability of This Warranty"** below for applicable transfer coverage.

▪ What About Algae Resistance

If the Owens Corning® Hip & Ridge shingle product you purchased were not specifically labeled as "Algae Resistant" (AR), then any discoloration caused by algae is not covered by this warranty as explained in the section below, "What Is Not Covered." However, if you did purchase Owens Corning® AR Hip & Ridge shingle products, they are covered for the period described in the chart at the end of this warranty (prorated after the first year) following the date of installation ("AR Warranty Period") against brown-black staining caused by growth of blue-green algae (primarily the cyanobacteria *Gloeocapsa magma*). We do not cover the effects of other growth such as mold, lichen, and green algae. If brown-black staining occurs during the AR Warranty Period, you will be entitled to the following remedy:

A. REMEDY FOR BLUE-GREEN ALGAE GROWTH—If your Owens Corning® AR Hip & Ridge shingle products are discolored by blue-green algae growth during the first year of the AR Warranty Period, we will cover the cost, including labor (such cost not to exceed the initial cost of the Owens Corning® AR Hip & Ridge shingle products plus the initial cost of installation), as reasonably determined by Owens Corning to repair, replace or recover the affected Owens Corning® AR Hip & Ridge shingle products, subject to certain limitations. We will not cover the cost to tear off or dispose of your Owens Corning® AR Hip & Ridge shingle products. For purposes of this Owens Corning® AR Hip & Ridge shingle products warranty, the term "repair" as used above refers to cleaning or otherwise removing any blue-green algae growth from affected Owens Corning® AR Hip & Ridge shingle products. Decisions regarding whether your Owens Corning® AR Hip & Ridge shingle products should be repaired, replaced or recovered will be made solely by Owens Corning.

B. PRORATION—If your Owens Corning® AR Hip & Ridge shingle products have been installed longer than one (1) year, labor will not be covered and we will prorate your Compensation (as defined within the compensation section herein) to take into account the number of months of use that you have enjoyed through the date of your claim. For example: If you make your claim in the last month of the fourth (4th) year of the AR warranty and the AR warranty length is ten (10) years, our Compensation to you will be reduced by 3/10ths and the reasonable material cost of the affected Owens Corning® AR Hip & Ridge shingles products (such cost not to exceed 7/10ths of the Owens Corning® AR Hip & Ridge material cost at time of purchase of the Owens Corning® AR hip & ridge shingle product).

▪ What Is Not Covered

Our warranty does not cover damage to your Owens Corning® Hip & Ridge shingle products or products due to any cause not expressly covered herein. After Owens Corning® Hip & Ridge shingle products leave the manufacturing facility, they are subjected to conditions and handling beyond our control which could affect their performance. This warranty does not cover any problems with non-defective Owens Corning® Hip & Ridge shingle products caused by conditions or handling beyond our control. Some examples of conditions not covered by this warranty include:

- Acts of God, such as hail, strong storms or winds over the maximum wind speed listed in the chart at the end of this warranty;
- Damage to or failure of your Owens Corning® Hip & Ridge shingle products as a result of damage to or the failure of the underlying roofing structure;
- Foot traffic on your roof or damage caused by object(s) (e.g., tree branches) falling on your roof;
- Improper or faulty installation of your Owens Corning® Hip & Ridge shingle products —installation must be in accordance with our written installation instructions and comply with local building codes.
- Shading, or variations in the color of your Owens Corning® Hip & Ridge shingle products or discoloration caused by algae, fungi, lichen or cyanobacteria (unless covered under the section **"What About Algae Resistance"** above);
- Inadequate ventilation or roof drainage. Some exceptions may apply. If you have questions, please contact us at 1-800-ROOFING;
- Settlement of the structure of your property or buckling or cracking of the deck over which your Owens Corning® Hip & Ridge shingle products were installed;
- Leaks caused by pre-existing conditions, structural failures(s) or damaged area(s) on or near the roof which are not part of the roofing system.
- Damage to your Owens Corning® Hip & Ridge shingle products caused by alterations made after completion of application, including structural changes, equipment installation, power washing, painting, or the application of cleaning solutions, coatings, or other modifications;
- Improper storage, handling or other conditions beyond our control;
- Damages caused by, or the cost to repair or replace, any non-Owens Corning® products.
- Improperly designed or installed gutter or downspout systems; and
- Any costs that you incur which are not authorized in advance by Owens Corning.

▪ Transferability of This Warranty (Note: Based on Original Installation Date)

You can transfer this warranty one time, anytime during the life of the warranty. For this warranty to be transferred, the new Owner must contact 1-800-ROOFING, within sixty (60) days after the date of the real estate transfer to obtain the benefits of this warranty. Proof of the purchase of both the Owens Corning® Hip and Ridge shingle product and the Owens Corning® Roofing Shingles along with installation date must be submitted at the same time. The AR Warranty Period and the Wind Warranty Period are fully transferable. See your Owens Corning Limited Warranty on Roofing Shingles for a description of the transferability of this warranty coverage.

COMPENSATION (as defined below)

Under the terms of this Limited Warranty, the manner of Compensation is at Owens Corning's sole discretion and may be issued in the form of cash settlement and/or material credit for Owens Corning® Products to an existing supplier of Owens Corning® Roofing materials. All costs must be pre-approved by Owens Corning. Note: The prorated material cost will be determined by the cost of your Owens Corning® Hip & Ridge shingle products at the original time of purchase.

NO MODIFICATIONS TO THIS WARRANTY

This warranty may not be changed or modified. No one, including any representative or employee of Owens Corning and any representative or employee of a contractor or installer has authority to assume any additional liability or responsibility for Owens Corning or in any way modify or change this warranty.

CLAIMS PROCESS

To make a claim under this warranty, you need to do so within thirty (30) days after you discover the problem. Just call us at 1-800-ROOFING or visit us at: <http://www.owenscorning.com/roofing>. To fully evaluate your claim, we may ask you to provide, at your expense, pictures of your Owens Corning® Hip & Ridge shingle products and/or Owens Corning® Hip & Ridge shingle products samples for us to test. Limitations

THIS WARRANTY IS EXCLUSIVE AND REPLACES ALL OTHER WARRANTIES, CONDITIONS, REPRESENTATIONS AND GUARANTEES, WHETHER EXPRESS OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, WHETHER BY STATUTE, AT LAW OR IN EQUITY AND IS LIMITED IN LENGTH TO THE EXPRESS WARRANTY PROVIDED ABOVE UNLESS A SHORTER PERIOD IS PERMITTED BY LAW.

THIS WRITTEN WARRANTY IS YOUR EXCLUSIVE WARRANTY FROM OWENS CORNING AND REPRESENTS THE SOLE REMEDY TO ANY OWNER OF OWENS CORNING® HIP & RIDGE SHINGLE PRODUCTS. OWENS CORNING MAKES NO OTHER REPRESENTATIONS, WARRANTIES OR GUARANTEES OF ANY KIND OTHER THAN THOSE STATED EXPLICITLY HEREIN.

YOUR REMEDY FOR DEFECTIVE OWENS CORNING® HIP & RIDGE SHINGLE PRODUCTS IS FULLY DESCRIBED IN THE PRECEDING SECTION, **"HOW LONG ARE YOU COVERED."** YOU ARE NOT ENTITLED TO ANYTHING MORE THAN WHAT IS DESCRIBED IN THAT SECTION. WE ARE NOT RESPONSIBLE FOR ANY INCIDENTAL, CONSEQUENTIAL, SPECIAL, PUNITIVE, OR OTHER DAMAGES OF ANY KIND INCLUDING DAMAGE TO YOUR STRUCTURE OR TO YOUR STRUCTURE'S CONTENTS WHETHER FOR BREACH OF THIS WARRANTY, NEGLIGENCE, STRICT LIABILITY OR OTHER CLAIMS DERIVED IN TORT OR FOR ANY OTHER CAUSE.

Some states or provinces do not allow limitations on how long an implied warranty lasts and/or do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. To the extent that this warranty is inconsistent with local law, this warranty shall be deemed modified to be consistent with such local law. This warranty gives you specific legal rights, and you may have other rights which vary from state to state or province to province.

FOR CANADA ONLY: The terms in this warranty, except to the extent lawfully permitted, do not include, restrict or modify but are in addition to any provincial laws.
