## 2. HAZARDS IDENTIFICATION

| <b>Skin contact</b> | <ul style="list-style-type: none"><li>• Wash off immediately with soap and plenty of cold water</li><li>• DO NOT use warm water because this will open up the pores of the skin, which will cause further penetration of fibers and dust</li><li>• Use a wash cloth to help remove fibers and dust</li><li>• DO NOT rub or scratch affected area</li><li>• Remove contaminated clothing and shoes</li><li>• If skin irritation persists, call a physician</li><li>• If fibers are seen penetrating from the skin, the fibers can be removed by applying and removing adhesive tape so that the fibers adhere to the tape and are pulled out of the skin</li><li>• Never use compressed air to remove fibers from skin</li></ul> |
| <b>Inhalation</b>   | <ul style="list-style-type: none"><li>• Remove to fresh air</li><li>• If symptoms persist, call a physician</li></ul>   |
| <b>Ingestion</b>    | <ul style="list-style-type: none"><li>• Accidental ingestion of this product is unlikely</li><li>• Rinse mouth with water and drink water to remove fibers from the throat</li><li>• If this does occur watch person for several days to make sure intestinal blockage does not occur</li><li>• If symptoms persist, call a physician</li></ul>   |

<b>IARC (International Agency for Research on Cancer)</b>	In October 2001, the International Agency for Research on Cancer (IARC) classified fiber glass wool as Group 3, "not classifiable as to its carcinogenicity to humans". The 2001 decision was based on human studies and animal research that have not shown an association between inhalation exposure to dust from fiber glass wool and the development of respiratory disease
<b>NTP (National Toxicology Program)</b>	In June 2011, The National Toxicology Program (NTP) removed biosoluble glass wool fibers from its list of possible carcinogens used for home and building insulation
