2 Product Description and Materials




Figure 1. Thermasheath-SI (Left) and Thermasheath (Right)








Figure 2. Thermasheath-SI Instructions as Displayed on Board

2.1 The innovative products evaluated in this report are shown in Figure 1 and Figure 2.

- 2.1.1 Thermasheath-SI is a structural wall sheathing consisting of a fibrous sheathing board layer adhered to a proprietary Foam Plastic Insulating Sheathing (FPIS). The proprietary fibrous sheathing board is a laminated board made of fibered, specially treated plies that are pressure-laminated with a water-resistant adhesive. The surface finish consists of a facer on one or both sides. The FPIS layer consists of a proprietary insulation board with a closed-cell rigid polyisocyanurate foam core and kraft reinforced aluminum facers on both sides. Both sides have a reflective surface.
 - 2.1.1.1 The FPIS layer complies with ASTM C1289 Type I, Class 1 and Class 2.
- 2.1.2 Thermasheath is a non-structural FPIS panel consisting of a closed cell rigid polyisocyanurate (polyiso) foam core bonded to reinforced aluminum facers on each side. Both sides have a reflective surface.
 - 2.1.2.1 Thermasheath complies with ASTM C1289 Type I, Class 1 and Class 2.
 - 2.1.2.2 For a more comprehensive evaluation of Thermasheath, see Report Number 1309-03.

3 Definitions

- 3.1 New Materialsⁱⁱ are defined as building materials, equipment, appliances, systems, or methods of construction not provided for by prescriptive and/or legislatively adopted regulations, known as alternative materials.ⁱⁱⁱ The design strengths and permissible stresses shall be established by tests^{iv} and/or engineering analysis.^v
- 3.2 <u>Duly Authenticated Reports</u> and <u>Research Reports</u> are test reports and related engineering evaluations, which are written by an <u>approved agency</u> and/or an <u>approved source</u>.
 - 3.2.1 These reports contain intellectual property and/or trade secrets, which are protected by the <u>Defend Trade</u> Secrets Act (DTSA).×
- 3.3 An <u>approved agency</u> is "approved" when it is <u>ANAB ISO/IEC 17065 accredited</u>. DrJ Engineering, LLC (DrJ) is listed in the ANAB directory.
- 3.4 An <u>approved source</u> is "approved" when a professional engineer (i.e., <u>Registered Design Professional</u>) is properly licensed to transact engineering commerce. The regulatory authority governing approved sources is the <u>state legislature</u> via its professional engineering regulations.^{xi}
- 3.5 Testing and/or inspections conducted for this <u>Duly Authenticated Report</u> were performed by an <u>ISO/IEC 17025</u> accredited testing laboratory, an <u>ISO/IEC 17020</u> accredited inspection body, and/or a licensed <u>Registered Design Professional (RDP)</u>.
 - 3.5.1 The Center for Building Innovation (CBI) is ANABxii ISO/IEC 17025 and ISO/IEC 17020 accredited.
- 3.6 The regulatory authority shall <u>enforce</u>^{xiii} the specific provisions of each legislatively adopted regulation. If there is a non-conformance, the specific regulatory section and language of the non-conformance shall be provided in writing^{xiv} stating the nonconformance and the path to its cure.
- 3.7 The regulatory authority shall accept <u>Duly Authenticated Reports</u> from an <u>approved agency</u> and/or an <u>approved source</u> with respect to the quality and manner of use of new materials or assemblies as provided for in regulations regarding the use of alternative materials, designs, or methods of construction.*v
- 3.8 ANAB is an International Accreditation Forum (IAF) Multilateral Recognition Arrangement (MLA) signatory where recognition of certificates, validation, and verification statements issued by conformity assessment bodies accredited by all other signatories of the IAF MLA with the appropriate scope, shall be approved.xvi Therefore, all ANAB ISO/IEC 17065 Duly Authenticated Reports are approval equivalent.xvii
- 3.9 Approval equity is a fundamental commercial and legal principle.xviii

5.1 A nationally recognized <u>testing laboratory</u> such as CBI, states that the materials, designs, methods of construction, and/or equipment have met nationally recognized standards and/or have been tested and found suitable for use in a specified manner.

6 Tabulated Properties Generated from Nationally Recognized Standards

6.1 General

- 6.1.1 Thermasheath-SI and Thermasheath are used as wall sheathing and continuous insulation in buildings constructed in accordance with the IBC and IRC.
 - 6.1.1.1 Thermasheath-SI and Thermasheath contain foam plastics complying with <u>IBC Section 2603</u> and <u>IRC Section R316</u>.
 - 6.1.1.2 Thermasheath-SI is used as insulating structural wall sheathing to provide lateral load resistance (wind and seismic) for braced wall panels and shear walls used in wood and light-frame steel construction.
 - 6.1.1.3 Thermasheath-SI is used as structural wall sheathing to provide resistance to transverse loads for wall assemblies used in wood and light-frame steel construction.
 - 6.1.1.4 Thermasheath-SI is used as structural wall sheathing to provide resistance to uplift loads for wall assemblies used in wood and light-frame steel construction.
- 6.1.2 Thermasheath is a non-structural FPIS panel used as thermal insulation within the building envelope, including, but not limited to, attic, crawlspace, wall, roof, ceiling, floor and foundation assemblies.
 - 6.1.2.1 Thermasheath is used as insulating sheathing applied as in-fill to portions of walls that are not designed as braced wall panels or shear walls.
 - 6.1.2.2 Thermasheath is used as second layer of insulating sheathing over Thermasheath-SI.
- 6.1.3 Thermasheath-SI and Thermasheath shall not be used as a nail base for other building products.
- 6.1.4 An approved draftstop material when installed in accordance with **Section 6.6**.
- 6.1.5 The Environmental Product Declarations (EPD) for Thermasheath-SI and Thermasheath are available at polyiso.org.

6.2 Structural Applications

6.2.1 General Provisions:

- 6.2.1.1 Except as otherwise described in this report, Thermasheath-SI shall be installed in accordance with the applicable building codes listed in **Section 4** using the provisions set forth therein for the design and installation of Wood Structural Panels (WSP).
 - 6.2.1.1.1 Thermasheath-SI is permitted to be designed in accordance with SDPWS for the design of shear walls using the methods set forth therein, including the perforated shear wall methodology, and subject to the SDPWS boundary conditions, except as specifically allowed in this report.
- 6.2.1.2 Anchorage for in-plane shear shall be provided to transfer the induced shear force into and out of each shear wall.
 - 6.2.1.2.1 For wind design, anchor bolt spacing shall not exceed 6' (1,829 mm) o.c.
 - 6.2.1.2.2 For seismic design, anchor bolt spacing shall not exceed 4' (1,219 mm) o.c.
- 6.2.1.3 The maximum aspect ratio for Thermasheath-SI shall be 4:1 (height:width).
- 6.2.1.4 The minimum full height panel width shall be 24" (51 mm).
- 6.2.1.5 When used in light-frame wood construction, all panel edges shall be blocked with a minimum 2x nominal lumber.





- 6.2.1.6 Thermasheath-SI on wood studs shall be installed with one of the following:
 - 6.2.1.6.1 Staples shall be a minimum 16-gauge, ⁷/₁₆" crown and penetrate a minimum of 1" into the stud.
 - 6.2.1.6.2 Nails shall be minimum 0.113" x $2^{3}/_{8}$ " and penetrate a minimum of $1^{1}/_{4}$ " into the stud.
- 6.2.1.7 Thermasheath-SI on steel studs shall be installed with #8 pan head screw with a minimum of three thread lengths extending beyond the stud.
- 6.2.1.8 Staples must be countersunk beneath the surface of the foam plastic sheathing. Nails and screws may be countersunk beneath the surface of the foam plastic sheathing.
- 6.2.1.9 Installation is permitted for single top plate (advanced framing method) or double top plate applications.
- 6.2.1.10 Where Thermasheath-SI is installed with ½" gypsum wallboard on the interior side of the wall, the gypsum sheathing shall be applied to the interior side of the wall assembly and fastened with a minimum 5d cooler nails or 1½" #6 types W or S screws.







- 6.2.2 Simplified IRC Bracing Provisions:
 - 6.2.2.1 Thermasheath-SI is permitted to be used in accordance with the IRC simplified bracing method of <u>IRC</u> Section R602.12 as modified by **Table 1**.
 - 6.2.2.2 All other provisions of the IRC simplified bracing method shall be met.

- 1. This simplified bracing table is based on the provisions of <u>IRC Section R602.12</u>. All provisions therein shall be observed, except that this table shall replace <u>IRC Table R602.12.4</u> and Thermasheath-SI shall replace the sheathing material.
- 2. Thermasheath-SI shall be installed on 2x4 or 2x6 studs spaced 16" o.c. and fastened with minimum 1/2" crown staples spaced 3":6" (edge:field) per **Section 9**. Fastener edge distance shall be a minimum of 3/6". Nails with a head diameter and length greater than the 13/4" x 0.120" nails are also permissible. Increase the required units by 1 where 7/16" crown staples are used.
- 3. Minimum 1/2" gypsum wallboard attached to the interior side of the wall in accordance with IRC Section R702.3.5 and IRC Table R702.3.5.
- 4. Interpolation shall not be permitted.
- 5. Cripple walls or wood-framed basement walls in a walk-out condition shall be designated as the first story and the stories above shall be re-designated as the second and third stories, respectively, and shall be prohibited in a three-story structure.
- 6. Actual lengths of the sides of the circumscribed rectangle shall be rounded to the next highest unit of 10 when using this table.
- 7. For Exposure Category C, multiply bracing units by a factor of 1.20 for a one-story building, 1.30 for a two-story building, and 1.40 for a three-story building.
- 8. Maximum stud spacing is 16" o.c.





- 6.2.3 Prescriptive IRC Bracing Applications:
 - 6.2.3.1 Thermasheath-SI may be used on braced wall lines as an equivalent alternative to Method WSP of the IRC, when installed in accordance with IRC Section R602.10 and this report.
 - 6.2.3.2 For wind design, required braced wall panel lengths for Thermasheath-SI shall be as shown in **Table 2** and shall be used in conjunction with IRC Table R602.10.3(2), which provides the required adjustments.
 - 6.2.3.3 For seismic design, required braced wall panel lengths for Thermasheath-SI shall be as shown in **Table 3** and shall be used in conjunction with <u>IRC Table R602.10.3(4)</u>, which provides the required adjustments.
 - 6.2.3.4 Thermasheath-SI may be used to brace walls of buildings as an alternative to the IRC Continuous Wall Bracing provisions, <u>IRC Section R602.10.4</u> (CS-WSP), in accordance with the bracing amounts shown in **Table 2** of this report, as adjusted in accordance with <u>IRC Table R602.10.3(2)</u>.
 - 6.2.3.5 Use of Thermasheath-SI with Method CS-PF is also permitted, in lieu of WSP specified in accordance with IRC Section R602.10.6.4.
 - 6.2.3.6 Where a building or portion thereof, does not comply with one or more of the bracing requirements within the prescriptive section of the IRC, those portions shall be designed and constructed in accordance with IRC Section R301.1.

- 1. Thermasheath-SI shall be installed on 2x4 or 2x6 studs spaced 16" o.c. and fastened with minimum 1/2" staples spaced 3":6" (edge:field) per **Section 9**. If 7/16" staples are used, increase length of bracing by a factor of 1.1.
- 2. Demonstrates equivalency to <u>IRC Table R602.10.3(1)</u>. All adjustment factors from <u>IRC Table R602.10.3(2)</u> shall be applied, except when used with method CS-PF, a minimum of 1/2" gypsum sheathing shall be applied to the interior side of the wall assembly and fastened with a minimum 5d cooler nails or 11/4" #6 types W or S screws spaced 8" o.c. at panel edges and 8" o.c. in the field of the panels
- 3. Minimum ½" gypsum wallboard must be installed as part of the wall assembly. Where gypsum wallboard is not applied to the interior side of the wall assembly, bracing lengths shall be multiplied by a factor of 1.8.
- 4. Where studs are spaced 24" o.c., bracing lengths shall be multiplied by a factor of 1.1.
- 5. The addition of gypsum wallboard to Thermasheath-SI wall assemblies provides a benefit greater than the SDPWS additive method for wood structural panels.
- Bracing lengths are the results of comparative equivalency testing and analysis using both tested and published design values as points of comparison. DrJ relies upon the design values published in the codes and standards listed in **Section 4** that are adopted into law and that the manufacturer of those products stand behind. DrJ performs all equivalency analysis based on legally defined design values, the responsibility for which is the manufacturer of those products or the members of the associations that publish those design values.

- 1. Thermasheath-SI shall be installed on 2x4 or 2x6 studs spaced 16" o.c. and fastened with minimum 1/2" staples spaced 3":6" (edge:field) per **Section 9**. If 7/16" staples are used, increase length of bracing by a factor of 1.1.
- 2. Demonstrates equivalency to <u>IRC Table R602.10.3(3)</u>. DrJ relies upon the design values published in the codes and standards listed in **Section** 4 that are adopted into law and that the manufacturer of those products stand behind. DrJ performs all equivalency analysis based on legally defined design values, the responsibility for which is the manufacturer of those products or the members of the associations that publish those design values.





6.2.4 Thermasheath-SI CS-PF:

- 6.2.4.1 A "Thermasheath-SI CS-PF" was tested and evaluated for equivalency to the IRC Method CS-PF in accordance with IRC Section R602.10.6.4 and IRC Table R602.10.5.
- 6.2.4.2 <u>IRC Table R602.10.5</u> establishes the contributing length bracing of the CS-PF as equivalent to 1.5 times its actual length and that it contributes this length of bracing to that required by method CS-WSP.
- 6.2.4.3 The capacity of the Thermasheath-SI CS-PF exceeds the capacity of the IRC Method CS-WSP and is therefore permitted to be substituted for an equivalent length of bracing.




Figure 3. Thermasheath-SI CS-PF Back Elevation

- 6.2.4.4 The Thermasheath-SI CS-PF is shown in **Figure 3** through **Figure 6**:




Figure 4. Thermasheath-SI CS-PF Front Elevation 1








Figure 5. Thermasheath-SI CS-PF Front Elevation 2






Figure 6. Thermasheath-SI CS-PF Section B-B





- 6.2.5 Alternative Prescriptive IRC Bracing Applications:
 - 6.2.5.1 As an alternative to **Section 6.3.3**, the following provisions are permitted:
 - 6.2.5.1.1 Thermasheath-SI may be used on braced wall lines as an equivalent alternative to Method WSP of the IRC, when installed in accordance with <u>IRC Section R602.10</u> and this report.
 - 6.2.5.1.2 Thermasheath-SI may be used to brace walls of buildings as an alternative to the Continuous Wall Bracing provisions of <u>IRC Section R602.10.4</u>.
 - 6.2.5.1.3 Required braced wall panel lengths for Thermasheath-SI shall be as determined by the equivalency factor shown in **Table 4** and <u>IRC Table R602.10.3(1)</u> and <u>IRC Table R602.10.3(3)</u>, including all footnotes.
 - 6.2.5.1.3.1 Bracing lengths in these tables for Method WSP or CS-WSP shall be multiplied by the equivalency factor listed in **Table 4**.

- 6.2.5.1.3.2 These braced wall line length equivalency factors are based on equivalency testing and are used to comply with Method WSP and CS-WSP of the IRC.
- 6.2.5.1.3.3 Thermasheath-SI tested equivalency factors in **Table 4** allow the user to determine the length of bracing required, by multiplying the factor from **Table 4** by the length shown in the WSP or CS WSP columns in IRC Table R602.10.3(3) as modified by all applicable factors in IRC Table R602.10.3(2) and IRC Table R602.10.3(4), respectively.
- 6.2.5.1.4 All IRC prescriptive bracing minimums, spacing requirements, and rules must still be met.
- 6.2.6 Prescriptive IBC Conventional Light-Frame Wood Construction:
 - 6.2.6.1 Thermasheath-SI may be used to brace exterior walls of buildings as an equivalent alternative to the WSP method of the IBC when installed with 1/2" gypsum in accordance with the conventional light frame construction method of IBC Section 2308.6 and this report.
- 6.2.7 Performance-Based Construction:
 - 6.2.7.1 Thermasheath-SI panels used in wall assemblies designed as shear walls are permitted to be designed in accordance with the methodology used in SDPWS for WSP using the capacities shown in **Table 5**, **Table 6**, **Table 7** and **Table 8**.
 - 6.2.7.2 Thermasheath-SI panel shear walls are permitted to resist horizontal wind load forces using the allowable shear loads (in pounds per linear foot) set forth in **Table 5** and **Table 6**.

- 7. Where R-SEAL 2000 LF is not applied along the framing members, the tabulated allowable unit shear capacity shall be divided by 2.9.









6.2.8 Seismic Design:

- 6.2.8.1 Thermasheath-SI shear walls that require seismic design in accordance with <u>IBC Section 1613</u> shall use the seismic allowable unit shear capacities set forth in **Table 7**.
 - 6.2.8.1.1 The response modification coefficient, R, system overstrength factor, Ω_0 , and deflection amplification factor, C_d indicated in **Table 7**, shall be used to determine the base shear, element design forces and design story drift in accordance with ASCE 7 Chapter 12 and Section 14.5.

6.2.9.1 Thermasheath-SI panels are permitted to resist uplift wind load forces using the allowable uplift loads (in pounds per linear foot) set forth in **Table 8**.

6.3 Water-Resistive Barrier (WRB)

- 6.3.1 Thermasheath-SI and Thermasheath may be used as a WRB as prescribed in <u>IBC Section 1403.2</u> xxiii and <u>IRC Section R703.2</u> when installed on exterior walls as described in this section.
- 6.3.2 Thermasheath-SI and Thermasheath shall be installed with board joints placed directly over exterior framing spaced a maximum of 24" (610 mm) o.c. The fasteners used to attach the board shall be installed in accordance with **Section 9**.
- 6.3.3 All joints between boards shall be sealed by R-SEAL 3000, R-SEAL Construction Tape or R-SEAL 2000 LF per the manufacturer installation instructions.
- 6.3.4 A separate WRB may also be provided. If a separate WRB method is used, taping of the sheathing joints is not required.
- 6.3.5 Flashing of corners, windows, doors and other through-wall penetrations is required and shall comply with the applicable code.
- 6.3.6 Where Thermasheath-SI is used intermittently along a braced wall line, Thermasheath may be used as infill between the Thermasheath-SI panels. In this application, the WRB is maintained, provided all seams and joints between boards are covered by R-SEAL 3000, R-SEAL Construction Tape or R-SEAL 2000 LF.
- 6.3.7 Thermasheath-SI and Thermasheath have water resistance properties as shown in **Table 11**.

- 6.4.2 Thermasheath-SI and Thermasheath have the thermal properties as shown in **Table 12**.

6.5 Air Barrier

- 6.5.1 Thermasheath-SI and Thermasheath meet the requirements of <u>IRC Section N1102</u>, <u>IECC Section C402</u> and <u>IECC Section R402</u> for use as a component of the air barrier when installed in accordance with the manufacturer installation instructions and this report.
- 6.5.2 The air permeance of an air barrier material is defined by the IECC and the Air Barrier Association of America (ABAA) as being no greater than 0.02 L/(s·m²) at 75 Pa pressure difference when tested in accordance with ASTM E2178.
- 6.5.3 The air barrier properties of Thermasheath-SI and Thermasheath are shown in **Table 13**.

6.5.4 When used as part of an air barrier assembly, all sheathing panel joints shall be sealed with R-SEAL 3000, R SEAL Construction Tape or R-SEAL 2000 LF. The transitions, including top and bottom of walls, and all penetrations shall also be sealed in accordance with the manufacturer installation instructions and this report.

6.6 Draftstop

- 6.6.1 Thermasheath-SI and Thermasheath may be used as a draftstop material in accordance with <u>IBC Section</u> 708.4.2, xxiv IBC Section 718.3, IBC Section 718.4 and IRC Section R302.12.
- 6.6.2 When installed as a draftstop, Thermasheath-SI and Thermasheath shall be installed in accordance with **Section 9**.





6.7 Fire Safety Performance

- 6.7.1 Surface Burning Characteristics:
 - 6.7.1.1 Thermasheath-SI and Thermasheath panels have flame spread and smoke developed ratings shown in **Table 14**, when tested in accordance with ASTM E84 per <u>IBC Section 2603.3</u> and <u>IRC Section R316.3</u>.

- 6.7.2 Thermal Barrier and Ignition Barrier (IBC and IRC Buildings):
 - 6.7.2.1 Thermasheath-SI and Thermasheath, up to 41/2" in walls only or ceilings only is approved for use in attics, crawls spaces or other uninhabited spaces without a thermal barrier or ignition barrier, based on large-scale testing in accordance with NFPA 286 per IBC Section 2603.9 and IRC Section R316.6.
 - 6.7.2.2 Thermasheath-SI and Thermasheath, up to 1" in walls and ceilings is approved for use in attics, crawls spaces or other uninhabited spaces without a thermal barrier or ignition barrier, based on large-scale testing in accordance with NFPA 286 per IBC Section 2603.9 and IRC Section R316.6.
 - 6.7.2.3 Thermasheath-SI and Thermasheath, up to 12" (305 mm) in thickness where applicable, may be installed within the building envelope (including, but not limited to, attics, crawlspaces, wall, roof, floor and ceiling assemblies) of all building types when separated from the interior with a thermal barrier consisting of a minimum 1/2" gypsum wallboard or an approved equivalent in accordance with IBC Section 2603.4 and IRC Section R316.4.
 - 6.7.2.4 In applications where panels are used in both walls and ceilings, but only one is allowed to be left exposed per **Section 6.7.2.1** or **Section 6.7.2.3**, the other must meet the requirements of **Section 6.7.2.5**.
 - 6.7.2.5 Use without an approved thermal barrier or ignition barrier is limited to areas where:
 - 6.7.2.5.1 Access to the space is required by IRC Section R807.1 or IRC Section R408.4.
 - 6.7.2.5.2 Entry is made only for the purposes of repairs or maintenance.
 - 6.7.2.6 Panels may be installed in single or multiple layers.

 - 6.7.3.1.5 3 hours: <u>U904</u>, <u>U907</u> 6.7.3.1.6 4 hours: <u>U902</u>, <u>U907</u>





- 6.7.3.2 Thermasheath has been tested and meets the requirements of UL 263 (ASTM E119) in accordance with <u>IBC Section 703.2.1</u> and <u>IRC Section R302.1</u> for use in the following assembly designs when installed in accordance with the manufacturer installation instructions and this report:
 - 6.7.3.2.1 45 minutes: <u>U424</u>, <u>U425</u>, <u>V321</u>, <u>V499</u>, <u>W456</u>
 - 6.7.3.2.2 1 hour: <u>U026, U326, U330, U354, U355, U364, U424, U425, U460, V454, V499, W417, W456</u>
 - 6.7.3.2.3 1.5 hours: U424, U425, V499, W456
 - 6.7.3.2.4 2 hours: U349, U424, U425, U905, U906, V332, V499, W456
 - 6.7.3.2.5 3 hours: <u>U904</u>, <u>U907</u> 6.7.3.2.6 4 hours: <u>U902</u>, <u>U907</u>
- 6.8 Non-Structural Applications
 - 6.8.1 Where other means of wall bracing are provided or are not required, and an approved exterior wall covering capable of separately resisting loads perpendicular to the face of the walls is installed over the sheathing, Thermasheath-SI and Thermasheath are permitted to be installed as follows:
 - 6.8.1.1 Fastening shall be sufficient to hold the Thermasheath-SI and Thermasheath in place until the exterior wall covering is installed. Once the wall covering is installed, the wall covering fasteners penetrate through the sheathing and into the wall framing, providing the necessary resistance to transverse loads.
 - 6.8.1.2 Fasteners include, but are not limited to, roofing nails and bugle head screws.
 - 6.8.1.3 Other means of fastening may also be used, such as certain adhesives which are compatible with the sheathing.
 - 6.8.1.4 Consult the manufacturer installation instructions for further details.
- 6.9 Where the application falls outside of the performance evaluation, conditions of use and/or installation requirements set forth herein, alternative techniques shall be permitted in accordance with accepted engineering practice and experience. This includes but is not limited to the following areas of engineering: mechanics or materials, structural, building science, and fire science.

7 Certified Performancexxv

- 7.1 All construction methods shall conform to accepted engineering practices to ensure durable, livable, and safe construction and shall demonstrate acceptable workmanship reflecting journeyman quality of work of the various trades. xxvi
- 7.2 The strength and rigidity of the component parts and/or the integrated structure shall be determined by engineering analysis or by suitable load tests to simulate the actual loads and conditions of application that occur.xxvii





8 Regulatory Evaluation and Accepted Engineering Practice

- 8.1 Thermasheath-SI and Thermasheath comply with the following legislatively adopted regulations and/or accepted engineering practice for the following reasons:
 - 8.1.1 Thermasheath-SI was evaluated to determine:
 - 8.1.1.1 Structural performance under lateral load conditions (wind and seismic) for use as an alternative to the IRC Intermittent Wall Bracing provisions of IRC Section R602.10, method WSP (Wood Structural Panel), and the IRC Continuous Wall Bracing provisions of IRC Section R602.10.4, methods CS-WSP (Continuous Sheathed Wood Structural Panel) and CS-PF (Continuous Sheathed Portal Frame).
 - 8.1.1.2 Structural performance under lateral load conditions for use as an alternative to the IRC simplified bracing provisions of IRC Section R602.12.
 - 8.1.1.3 Structural performance under lateral load conditions for use as an alternative to the IBC Conventional Wall Bracing provisions, <u>IBC Section 2308.6</u>, WSP (Wood Structural Panel) Method 3, for Type V construction.
 - 8.1.1.4 Structural performance under lateral load conditions for wind loading for use with the IBC performance based provisions. IBC Section 2211.1 for light-frame steel wall assemblies.
 - 8.1.1.5 Structural performance under lateral load conditions for both wind and seismic loading for use with the IBC performance-based provisions, <u>IBC Section 2306.1</u> and <u>IBC Section 2306.3</u> for light-frame wood wall assemblies.
 - 8.1.1.5.1 **Table 7** provides Seismic Design Coefficients (SDC) that conform to the requirements in ASCE 7 Section 12.2.1 and Table 12.2-1 for design of wall assemblies in buildings that require seismic design in accordance with ASCE 7 (i.e., all Seismic Design Categories).
 - 8.1.1.5.2 The basis for equivalency testing is outlined in Section 12.2.1.1 of ASCE 7:

Alternative Structural Systems. Use of seismic force-resisting systems not contains in Table 12.2-1 shall be permitted contingent on submittal to and approved by the Authority Having Jurisdiction and independent structural design review of an accompanying set of design criteria and substantiating analytical and test data. The design criteria shall specify any limitations on system use, including Seismic Design Category and height; required procedures for designing the system's components and connections; required detailing; and the values of the response modification coefficient, R; overstrength factor, Ω_0 ; and deflection amplification factor, C_d .

- 8.1.1.5.2.1 The basis of the seismic evaluation performed as part of this report is based on ASTM D7989 and testing per ASTM E2126 to establish SDCs that conform to the requirements of ASCE 7 Section 12.2.1.1.
- 8.1.1.6 Resistance to uplift loads for wall assemblies used in light-frame steel and wood construction in accordance with <u>IBC Section 1604.8.1</u>, <u>IBC Section 2304.10.8</u>, xxviii <u>IBC Section 2308.7.5</u> and <u>IRC Section R602.3.5</u>.
- 8.1.1.7 Resistance to transverse loads for wall assemblies used in light-frame steel and wood construction in accordance with <u>IBC Section 1609.1.1</u> and <u>IRC Section R301.2.1</u>.
- 8.1.1.8 Structural performance under lateral load conditions for use as an alternative to SDPWS Section 4.3 Wood Frame Shear Walls.





- 8.1.2 Thermasheath-SI and Thermasheath were evaluated to determine:
 - 8.1.2.1 Performance in accordance with foam plastic requirements of <u>IBC Section 2603</u> and <u>IRC Section R316</u>.
 - 8.1.2.2 Performance for use as insulating sheathing (R-Value) in accordance with <u>IRC Section N1102.1</u>, <u>IRC Section N1102.2</u>, <u>IECC Section C402</u> and <u>IECC Section R402</u>.
 - 8.1.2.3 Performance for use as a WRB in accordance with IBC Section 1403.2xxix and IRC Section R703.2.
 - 8.1.2.4 Performance for use as a vapor retarder in accordance with <u>IBC Section 202</u>, <u>IBC Section 1404.3</u>, xxx IRC Section R202 and IRC Section R702.7.
 - 8.1.2.5 Performance for use as an air barrier material in accordance with <u>IRC Section N1102.4</u> and <u>IECC Section R402.</u>
 - 8.1.2.6 Performance for use as a draftstop in accordance with <u>IBC Section 708.4.2</u>, xxxi <u>IBC Section 718.3</u>, <u>IBC Section 718.4</u> and IRC Section R302.12.
 - 8.1.2.7 Performance for use in buildings of Type V construction in accordance with <u>IBC Section 2603</u> and <u>IRC Section R316</u>.
 - 8.1.2.7.1 Surface burning characteristics in accordance with <u>IBC Section 2603.3</u> and <u>IRC Section R316.3</u>.
 - 8.1.2.7.2 Special approval for use without a thermal barrier or ignition barrier in accordance with <u>IBC Section 2603.4.1.6, IRC Section R316.5.3</u> and <u>IRC Section R316.5.4</u>.
 - 8.1.2.8 Performance for use in a fire resistance rated assembly in accordance with IBC Section 703.2.1.
- 8.1.3 Thermasheath was evaluated to determine its performance for use as non-structural in-fill on those portions of a wall assembly not otherwise designed as part of a braced wall panel or shear wall.
- 8.1.4 Use of Thermasheath-SI in a Portal Frame with Hold-Down (PFH) is outside the scope of this report.
- 8.1.5 Use of Thermasheath in applications where the exterior wall covering is unable to resist 100% of the transverse wind load is outside the scope of this report.
- 8.1.6 Performance of Thermasheath-SI used in light-frame steel construction to resist seismic loading is outside the scope of this report.
- 8.2 Any building code, regulation, and/or accepted engineering evaluations (i.e., research reports, <u>Duly Authenticated Reports</u>, etc.) that are conducted for this Listing were performed by DrJ Engineering, LLC (DrJ), an <u>ISO/IEC 17065 accredited certification body</u> and a professional engineering company operated by <u>RDP/approved sources</u>. DrJ is qualified^{xxxii} to practice product and regulatory compliance services within its scope of accreditation and engineering expertise, respectively.
- 8.3 Engineering evaluations are conducted with DrJ's ANAB <u>accredited ICS code scope</u> of expertise, which are also its areas of professional engineering competence.
- 8.4 Any regulation specific issues not addressed in this section are outside the scope of this report.





9 Installation

- 9.1 Installation shall comply with the approved construction documents, the manufacturer installation instructions, this report and the applicable building code.
- 9.2 In the event of a conflict between the manufacturer installation instructions and this report, the more restrictive shall govern.
- 9.3 Installation Procedure
 - 9.3.1 General:
 - 9.3.1.1 Fastener edge distance is a minimum of ³/₈" (9.5 mm) for both Thermasheath-SI and gypsum.
 - 9.3.1.2 Where used, always fasten staples parallel to the framing member.
 - 9.3.1.3 Where hold-down straps are used, install structural sheathing first, remove foam at strap's location, then install the strap over the face of the structural sheathing backer and attach per the manufacturer installation instructions.
 - 9.3.1.4 Where required, gypsum wallboard shall be a minimum ¹/₂" and installed with a minimum of #6 x 1¹/₄" Type W or S screws or 5d cooler nails. The fastener spacing shall be a maximum of 8" o.c. (76 mm) along the edge and in the field.
 - 9.3.2 Orientation:
 - 9.3.2.1 Thermasheath-SI and Thermasheath must be installed with the long dimension of the panels parallel to the framing behind and all panel edges supported by framing or blocking.
 - 9.3.2.2 Thermasheath-SI and Thermasheath must be installed over studs a nominal thickness of not less than 2" (51 mm) and spaced a maximum of 24" (610 mm) o.c., unless otherwise limited by this report.
 - 9.3.3 Fastener Type:
 - 9.3.3.1 Thermasheath-SI on Wood Studs:
 - 9.3.3.1.1 Minimum $^{7}/_{16}$ " crown by $1^{1}/_{4}$ " leg, 16-gauge staples or 0.113" x $2^{3}/_{8}$ " nails with a 1" minimum embedment into stud.
 - 9.3.3.2 Thermasheath-SI on Steel Studs:
 - 9.3.3.2.1 Minimum #8 pan head screw, with three thread lengths extending beyond the stud.
 - 9.3.3.2.2 ³/₁₆" diameter bead of Rmax R-SEAL 2000 LF placed along steel studs and top/bottom plates with ³/₈" edge distance.
 - 9.3.3.3 Thermasheath:
 - 9.3.3.3.1 Refer to the manufacturer installation instructions.
 - 9.3.4 Fastener Spacing:
 - 9.3.4.1 Thermasheath-SI on Wood Stud:
 - 9.3.4.1.1 Maximum of 3" o.c. (76 mm) along the edge and 6" o.c. in the field.
 - 9.3.4.2 Thermasheath-SI on Steel Stud:
 - 9.3.4.2.1 Maximum of 3" o.c. (76.2 mm) along the edge and 6" o.c. in the field.
 - 9.3.4.2.2 With R-SEAL 2000LF, maximum of 12" o.c. (76.2 mm) along the edge and in the field.
 - 9.3.4.3 Thermasheath:
 - 9.3.4.3.1 Refer to manufacturer installation instructions.
 - 9.3.5 Treatment of Joints:
 - 9.3.5.1 Thermasheath-SI sheathing joints shall be tightly butted at framing members and a single row of fasteners must be applied to both panel edges into the framing behind.
 - 9.3.5.2 Do not tack Thermasheath-SI to framing, but fasten each panel completely once fastening begins.





9.3.6 Window Treatments:

- 9.3.6.1 If windows are made to accommodate traditional ¹/₂" sheathing materials, order windows with adjustable nailing fins from the supplier. Door brick moldings may be planed or routed ³/₈" in order to accommodate the different sheathing thickness, either at the jobsite or by the millwork supplier.
- 9.3.6.2 Thermasheath-SI shall be installed with appropriate flashing and counter flashing in conformance with accepted building standards and in compliance with local building codes and the flashing manufacturer installation instructions.

 - 10.1.5 Thermal resistance property testing in accordance with ASTM C518
 - 10.1.6 Water vapor permeance testing in accordance with ASTM E96
 - 10.1.7 WRB testing in accordance with AATCC 127, ASTM E283, ASTM E331, and ASTM D1037
 - 10.1.8 Water absorption in accordance with ASTM C209 and ASTM C272
 - 10.1.9 Air permeance testing in accordance with ASTM E2178
 - 10.1.10 Flame spread and smoke developed rating tests in accordance with ASTM E84
 - 10.1.11 Room corner tests in accordance with NFPA 286
 - 10.1.12 Fire resistance ratings in accordance with UL 263
- 10.2 Information contained herein may include the result of testing and/or data analysis by sources that are approved agencies, approved sources, and/or RDPs. Accuracy of external test data and resulting analysis is relied upon.
- 10.3 Where pertinent, testing and/or engineering analysis are based upon provisions that have been codified into law through state or local adoption of regulations and standards. The developers of these regulations and standards are responsible for the reliability of published content. DrJ's engineering practice may use a regulation-adopted provision as the control. A regulation-endorsed control versus a simulation of the conditions of application to occur establishes a new material as being equivalent to the regulatory provision in terms of quality, strength, effectiveness, fire resistance, durability, and safety.
- 10.4 The accuracy of the provisions provided herein may be reliant upon the published properties of raw materials, which are defined by the grade mark, grade stamp, mill certificate, or <u>Duly Authenticated Reports</u> from <u>approved agencies</u> and/or <u>approved sources</u> provided by the supplier. These are presumed to be minimum properties and relied upon to be accurate. The reliability of DrJ's engineering practice, as contained in this <u>Duly</u> Authenticated Report, may be dependent upon published design properties by others.
- 10.5 Testing and engineering analysis: The strength, rigidity, and/or general performance of component parts and/or the integrated structure are determined by suitable tests that simulate the actual conditions of application that occur and/or by accepted engineering practice and experience.xxxiii
- 10.6 Where additional condition of use and/or regulatory compliance information is required, please search for Thermasheath-SI and Thermasheath on the DrJ Certification website.





11 Findings

- 11.1 As outlined in **Section 6**, Thermasheath-SI and Thermasheath have performance characteristics that were tested and/or meet applicable regulations and are suitable for use pursuant to its specified purpose.
- 11.2 When used and installed in accordance with this <u>Duly Authenticated Report</u> and the manufacturer installation instructions, Thermasheath-SI and Thermasheath shall be approved for the following applications:
 - 11.2.1 Lateral load resistance due to wind and seismic loads carried by shear walls.
 - 11.2.2 Use as an equivalent alternative to the CS-PF as described in <u>IRC Section R602.10.5</u> and <u>IRC Section R602.10.6</u>.
 - 11.2.3 Transverse load resistance due to components and cladding pressures on building surfaces.
 - 11.2.4 Uplift load resistance due to components and cladding pressures on building surfaces.
- 11.3 When installed in accordance with the manufacturer installation instructions and this report, Thermasheath-SI and Thermasheath comply with or are a suitable alternative to, the applicable sections of the codes listed in **Section 4** for the following applications:
 - 11.3.1 Performance of foam plastics in accordance with IBC Section 2603 and IRC Section R316.
 - 11.3.2 Performance for use as insulating sheathing in accordance with IRC Section N1102.1, <a href="IRC Section N1102.1, <a href="IRC Sect
 - 11.3.3 Performance for use as a WRB in accordance with IBC Section 1403.2 xxxiv and IRC Section R703.2.
 - 11.3.4 Performance for use as an air barrier in accordance with IRC Section N1102.4 and IECC Section C402.
 - 11.3.5 Performance for use as a draftstop in accordance with <u>IBC Section 708.4.2</u>, xxxv <u>IBC Section 718.3</u>, <u>IBC Section 718.4</u> and IRC Section R302.12.
 - 11.3.6 Performance for use in a fire resistance rated assembly in accordance with IBC Section 703.2.1.
 - 11.3.7 Flame spread and smoke developed indices in accordance with <u>IBC Section 2603.3</u> and <u>IRC Section R316.3</u>.
 - 11.3.8 Performance for use without a thermal barrier in accordance with <u>IBC Section 2603.4.1.6</u>, <u>IRC Section R316.5.3</u> and IRC Section R316.5.4.
 - 11.3.9 Performance for use without a thermal barrier or ignition barrier in accordance with <u>IBC Section 2603.9</u> and IRC Section R316.6 when installed in accordance with Section 6.7.2.
- 11.4 Unless exempt by state statute, when Thermasheath-SI and Thermasheath are to be used as a structural and/or building envelope component in the design of a specific building, the design shall be performed by an RDP.
- 11.5 Any application specific issues not addressed herein can be engineered by an <u>RDP</u>. Assistance with engineering is available from Rmax.
- 11.6 IBC Section 104.11 (IRC Section R104.11 and IFC Section 104.10 xxxvi are similar) in pertinent part states:
 - **104.11** Alternative materials, design and methods of construction and equipment. The provisions of this code are not intended to prevent the installation of any material or to prohibit any design or method of construction not specifically prescribed by this code. Where the alternative material, design or method of construction is not approved, the building official shall respond in writing, stating the reasons the alternative was not approved.





- 11.7 **Approved**: xxxviii Building regulations require that the <u>building official</u> shall accept <u>Duly Authenticated</u> <u>Reports</u>. xxxviii
 - 11.7.1 An approved agency is "approved" when it is ANAB ISO/IEC 17065 accredited.
 - 11.7.2 An <u>approved source</u> is "approved" when an <u>RDP</u> is properly licensed to transact engineering commerce.
 - 11.7.3 Federal law, <u>Title 18 US Code Section 242</u>, requires that where the alternative product, material, service, design, assembly, and/or method of construction is not approved, the building official shall respond in writing, stating the reasons why the alternative was not approved. Denial without written reason deprives a protected right to free and fair competition in the marketplace.
- 11.8 DrJ is a licensed engineering company, employs licensed RDPs and is an <u>ANAB-Accredited Product Certification Body</u> <u>Accreditation #1131</u>.
- 11.9 Through the <u>IAF Multilateral Agreements</u> (MLA), this <u>Duly Authenticated Report</u> can be used to obtain product approval in any <u>jurisdiction</u> or <u>country</u> because all ANAB ISO/IEC 17065 <u>Duly Authenticated Reports</u> are equivalent.xxxix

12 Conditions of Use

- 12.1 Material properties shall not fall outside the boundaries defined in **Section 6**.
- 12.2 As defined in **Section 6**, where material and/or engineering mechanics properties are created for load resisting design purposes, the resistance to the applied load shall not exceed the ability of the defined properties to resist those loads using the principles of accepted engineering practice.
- 12.3 Except as provided in **Section 6.7.2**, Thermasheath-SI and Thermasheath shall be fully protected from the interior of the building by an approved 15-minute thermal barrier or ignition barrier where required by the applicable code.

- 12.15 <u>Design loads</u> shall be determined in accordance with the regulations adopted by the <u>jurisdiction</u> in which the project is to be constructed and/or by the building designer (i.e., <u>owner</u> or RDP).
- 12.16 The actual design, suitability, and use of this report for any particular building, is the responsibility of the <u>owner</u> or the authorized agent of the owner.

 - 1.2.7 The AHJ shall accept <u>Duly Authenticated Reports</u> from <u>approved agencies</u> in respect to the quality and manner of use of new materials or assemblies as provided for in <u>IBC Section 104.11</u>.xlvii

 - 1.6.5.2 A test report from a commission-approved testing laboratory indicating that the product tested complies with the code,
 - 1.6.5.3 A product-evaluation report based upon testing, comparative or rational analysis, or a combination thereof, from a commission-approved product evaluation entity which indicates that the product evaluated complies with the code,





- 1.6.5.4 A product-evaluation report or certification based upon testing or comparative or rational analysis, or a combination thereof, developed and signed and sealed by a Florida professional engineer or Florida registered architect, which indicates that the product complies with the code, or
- 1.6.5.5 A statewide product approval issued by the Florida Building Commission.
- 1.6.6 The <u>Florida Department of Business and Professional Regulation</u> (DBPR) website provides a listing of companies certified as a <u>Product Evaluation Agency</u> (i.e., EVLMiami 13692), a <u>Product Certification Agency</u> (i.e., CER10642), and as a <u>Florida Registered Engineer</u> (i.e., ANE13741).
- 1.7 **Approved by Miami-Dade County (i.e., Notice of Acceptance [NOA])**: A Florida statewide approval is an NOA. An NOA is a Florida local product approval. By Florida law, Miami-Dade County shall accept the statewide and local Florida Product Approval as provided for in Florida legislation 553.842 and 553.8425.
- 1.8 **Approved by New Jersey**: Pursuant to the 2018 Building Code of New Jersey in <u>IBC Section 1707.1</u>

 <u>General</u>, IIII it states: "In the absence of approved rules or other approved standards, the building official shall accept duly authenticated reports from <u>approved agencies</u> in respect to the quality and manner of use of new materials or assemblies as provided for in the administrative provisions of the Uniform Construction Code (<u>N.J.A.C. 5:23</u>)". IIV Furthermore N.J.A.C 5:23-3.7 states: "Municipal approvals of alternative materials, equipment, or methods of construction."

 - 1.10.3 The <u>design strengths and permissible stresses</u> of any structural material...shall conform to the specifications and methods of design of accepted engineering practice performed by an approved source.^{lx}
