The cover is installed over the tieback with the perimeter base mechanically fastened to the soil retention system to provide a quick and easy detailing aid used with the SikaProof® waterproofing membrane systems.

#### **APPLICATION INSTRUCTIONS**

Install SikaProof® Tieback Cover by anchoring into lagging with either mechanical fasterners or SikaProof® Sandwich Tape. Install the field SikaProof® Membrane over the SikaProof® Tieback Cover and cut to fit around cover with 2" minimum overlap of membrane on the base. Secure Membrane to the base using SikaProof® Tape A+ or SikaProof® Tape-150A. Cover the remaining exposed section of the SikaProof® Tieback Cover with SikaProof® Tape A+ or SikaProof® Tape-150A.
