STORAGE STORAGE CONDITIONS

SHELF LIFE

Sikacoat P430 has a shelf life of 12 months if stored properly in original unopened, sealed and undamaged packaging.

APPLICATION INSTRUCTIONS

SURFACE PREPARATION

Surface must be dry and free of dirt, dust, oil, grease, wax, rust, chalky or loose paint, mildew and any other surface contamination that may inhibit adhesion. Power wash TPO membrane surface prior to Sikacoat P430 application.

MIXING

Mix Sikacoat P430 thoroughly before use. Do not dilute.

APPLICATION

Apply Sikacoat P430 using roller, brush or spray equipment. Rinse tools and equipment with water before using. Allow Sikacoat P430 to completely cure before the application of the Sikacoat roof coatings.

COVERAGE

Apply Sikacoat P430 at a rate of $\frac{1}{2}$ gallon per 100 square feet (0.2 L/m²) over smooth TPO surfaces.

CLEAN UP

Wet material and all tools and equipment may be cleaned with water. Rinse tools and equipment with water before using.

PRODUCT LIMITATIONS

LIMITATIONS

Precautions should be taken to prevent odors and/or vapors from entering the building/structure, including but not limited to turning off and sealing air intake vents or other means of ingress for odors and/or vapors into the building/structure during product application and cure.

- Do not apply Sikacoat P430 when surface or air temperature is below 50°F (10°C).
- Do not apply Sikacoat P430 if cold weather or freezing conditions, rain, heavy dew, moisture or fog is expected within 48 hours of application.
- Drying time may vary depending upon wet film thickness, temperature, humidity and air movement.
- Not for use over EPDM, PVC or other single ply membranes.
