3. PRODUCT DESCRIPTION

USES: Pango Claw is a multi-layered tape that is used to seal Pango® Wrap along its terminating edges (interior and perimeter) to the slab while the concrete is placed. Pango Claw allows wet concrete to cast into the textured top surface to form a mechanical bond/seal.

COMPOSITION: Pango Claw is composed of polyethylene film, polyolefin scrim, and an acrylic, pressure-sensitive adhesive.

SIZE: 3" X 180'

5. INSTALLATION

UNDER SLAB & CRAWL SPACE: Clean surface of Pango Wrap to ensure that it is free of moisture, frost, dirt, and debris prior to the installation of Pango Claw. When ready to apply Pango Claw, peel back the release liner and apply to Pango Wrap. Pango Claw should be completely on Pango Wrap. To detail, cut Pango Claw with a box knife or scissors.

TIP: Wrap the release liner back over the entire roll while unrolling Pango Claw. This technique will allow the release liner to pull off easily and keep it out of the way.

5. INSTALLATION *Continued...*

Pango Claw should be installed above 40°F. In temperatures below 40°F take extra care to remove moisture or frost from the area of adhesion. Do not exceed 7 days between Pango Claw installation and concrete placement or full protection from UV and weather exposure.
