

Surface Preparation

Concrete and masonry surfaces: Surfaces must be free of frost, damage, and all bond-inhibiting materials, including dirt, efflorescence, form oil and other foreign matter. Loose or damaged material must be removed by water-blasting, sandblasting or mechanical wire brushing and repaired. Avoid application over irregular surfaces. Resurface, patch or level surfaces to required tolerance and smoothness with appropriate Sto leveling materials.

Mixing

Mix Sto Flexyl with an equal amount by weight of Portland cement. Mix 1/2 batch at a time by adding approximately 22-1/2 lbs. (10.2 kg) cement to 1/2 pail of Sto Flexyl in a clean mixing pail.

Mix with a clean, rust-free electric drill and paddle. Allow to set approximately five minutes, adjust mix if necessary, then remix to a uniform consistency.

Application

Apply only to sound and clean, dry, properly prepared, frost-free surfaces.

As an adhesive for insulation board:

Apply a uniform coat of Sto Flexyl on the wall surface up to 1/8" (3 mm) thick. Stipple the Sto Flexyl by lightly pressing the trowel into the wet adhesive then removing the trowel from the surface. Immediately install insulation board by pressing firmly into the wet adhesive.

As a waterproof base coat: Apply Sto

Flexyl to an approximate wet thickness of 1/8" (3 mm). Work horizontally or vertically in strips of 40" (1 m), and immediately embed Sto Mesh into the wet Sto Flexyl by troweling from the center to the edges of the mesh. Avoid wrinkles in the mesh and smooth the base coat to eliminate trowel marks. Sto Flexyl must completely hide the reinforcing mesh color when dry. Reapply additional base coat material if necessary to achieve minimum thickness as soon as the first application is dry.

As a foundation waterproofer: Apply Sto Flexyl to a maximum thickness of 1/8" (3 mm) in one application.

Limitations

 Use Sto Flexyl only when surface and ambient temperatures are above 40°F (4°C) during application and drying period. The application must result in a smooth, closed surface. Repeat application when the first coat is dry, if necessary, to fill all voids, pinholes, etc.

As a crack repair material for cracks up to 1/8" (3 mm) wide in prepared concrete, masonry and plaster: Remove surface contamination, loose and deteriorated material. Embed 6" (152 mm) wide Sto Mesh in Sto Flexyl centered over the crack and feather beyond the edges of the fabric.

Curing/Drying

Sto Flexyl dries within 24 hours under normal conditions [70°F (21°C), 50% RH]. Cool, damp conditions extend drying and curing times.

NOTE: Sto Primer is required over Sto Flexyl prior to application of Sto Finish Coat.

Protect from rain, freezing and continuous high humidity until completely dry.

Clean Up

Clean tools and equipment with water immediately after use. Dried material can only be removed mechanically.

- Sto Flexyl is not recommended for use on wood surfaces.
- Sloped surfaces: refer to Sto details.
