SECTION 4: FIRST AID MEASURES

4.1. Description of First-aid Measures

4.2. Most Important Symptoms and Effects Both Acute and Delayed

General: Causes damage to organs (respiratory organs) through prolonged or repeated exposure (inhalation). May cause cancer (inhalation) Inhalation is not an expected route of exposure during normal use of this product.

Inhalation: Prolonged exposure may cause irritation. <u>Accelerated Silicosis</u> can occur with exposure to high concentrations of respirable crystalline silica over a relatively short period; lung lesions can appear within five years of the initial exposure. The progression can be rapid. Accelerated silicosis is similar to chronic or ordinary silicosis, except that lung lesions appear earlier and the progression is more rapid.

<u>Acute Silicosis</u> can occur with exposures to very high concentrations of respirable crystalline silica over a very short time period, sometimes as short as a few months. The symptoms of acute silicosis include progressive shortness of breath, fever, cough and weight loss. Acute silicosis can be fatal.

Skin Contact: May cause slight irritation.

Eye Contact: May cause slight irritation to eyes. **Ingestion:** Ingestion may cause adverse effects.

Chronic Symptoms: May cause cancer (inhalation). Causes damage to organs (respiratory organs) through prolonged or repeated exposure (inhalation). This product contains crystalline silica. Long term exposure to respirable crystalline silica results in a significant risk of developing silicosis; a seriously disabling and fatal lung disease, and other non-malignant respiratory disease, lung cancer, kidney effects, and immune system effects.

4.3. Indication of Any Immediate Medical Attention and Special Treatment Needed

If exposed or concerned, get medical advice and attention. If medical advice is needed, have product container or label at hand.

SECTION 5: FIRE-FIGHTING MEASURES

5.1. Extinguishing Media

Suitable Extinguishing Media: Water spray, fog, carbon dioxide (CO₂), alcohol-resistant foam, or dry chemical. **Unsuitable Extinguishing Media:** Do not use a heavy water stream. Use of heavy stream of water may spread fire.

5.2. Special Hazards Arising From the Substance or Mixture
