
UNOPPOSED TEE ATTACHMENT CLIP (UTAC) INSTALLATION GUIDE

DESCRIPTION


The Unopposed Cross Tee Clip is used to create code compliant cross tee connections when a cross tee is installed in a main tee without another cross tee directly opposite. The UTAC complies with ASTM E580 for category C, and D-F seismic installations. Requires a pop rivet for installation.



ADVANTAGES


- Useful for running bond and other off module layouts
- Complies with ASTM E580 for category C, and D-F installations
- Helps keep cross tees square during installation
- Won't interfere with panel installation or removal
- Works with all Donn brand suspension systems
- Ensures the Donn suspension system warranty will apply


Typical Running Bond Patterns




INSTALLATION


At the cross tee locations without an opposite cross tee, slide the UTAC clip in to the cross tee route on the **left side** of the existing cross tee clip.






On the cross tee side of the main tee, install a pop rivet through the upper cross tee clip rivet hole and the hole in the UTAC clip. Steel shank pop rivets must be used for category D-F installations.





Using snips, trim the cross tee clip as required in order to minimize interference with ceiling panel and fixture installation.
