Deck Type 4I: Lightweight Concrete, Insulated, over Structural Concrete Deck
Deck Description: Elastizell Range II Lightweight Insulating Concrete, minimum 300 psi.
System Type A(1): One or more layers of insulation adhered with DASH Adhesive. Membrane fully adhered.

All General and System Limitations apply. Roof accessories not listed in Table 1 of this NOA are not approved and shall not be installed unless said accessories demonstrate compliance with prescriptive Florida Building Code requirements and are field fabricated utilizing the approved membranes listed in Table 1.

Note: All insulation shall be adhered to the deck with DASH Adhesive at a rate of 1 gal./sq. Please refer to Roofing Application Standard RAS 117 for insulation attachment. Insulation listed as base layer only shall be used only as base layers with a second layer of approved top layer insulation installed as the final membrane substrate. Composite insulation panels used as a top layer shall be placed with the Polyisocyanurate side facing down.

Barrier: None.

Membrane Option 1: VersiWeld or VersiWeld HS, 45 or 60 mil membrane or VersiWeld Plus TPO or 80 membrane fully adhered to the insulation using VersiWeld Bonding Adhesive applied at a rate of 1 gal/60 ft² (finished surface) Outside 1.5" of side laps are heat welded.
 Or
 VersiFleece TPO 100 or 115 mil membrane fully adhered to the insulation using DASH Adhesive applied at a rate of 1 gal/sq. or Aqua Base 120 Bonding Adhesive applied to the substrate at a rate of 1 gal/120 ft². Outside 1.5" of side laps are heat welded.
 Or
 VersiFleece AC TPO membrane adhered to the insulation Cold Applied Adhesive applied to the substrate at a rate of 1 gal/67 ft². Outside 1.5" of side laps are heat welded.

Maximum Design Pressure (Opt. 1): -340 psf (See General Limitation #9)

Membrane Option 2: VersiWeld or VersiWeld HS, 45 or 60 mil membrane or VersiWeld Plus TPO or 80 membrane fully adhered to the insulation using Aqua Base 120 Bonding Adhesive applied to the substrate at a rate of 1 gal/120 ft² (finished surface). Outside 1.5" of side laps are heat welded.

Maximum Design Pressure (Opt. 2): -90 psf (See General Limitation #9)



Membrane Type: Single Ply, Thermoplastic, TPO, VersiFleece
Deck Type 4: Lightweight Concrete, Non-insulated, over Steel Deck
Deck Description: Celcore Cellular Lightweight Concrete, minimum 300 psi., over 18-22 ga Steel Deck
System Type F(1): Membrane fully adhered to lightweight insulating concrete deck

All General and System Limitations apply. Roof accessories not listed in Table 1 of this NOA are not approved and shall not be installed unless said accessories demonstrate compliance with prescriptive Florida Building Code requirements and are field fabricated utilizing the approved membranes listed in Table 1.

Deck: Minimum 22 ga. steel deck secured to supports space at maximum 4 ft o.c. with ITW Buildex Traxx/5 spaced at 6" o.c.

Vapor Retarder: None.

Membrane: VersiFleece TPO 100 or 115 mil membrane fully adhered to the lightweight deck using DASH Adhesive applied at a rate of 1 gal/sq. Outside 1.5" of side laps are heat welded.

Maximum Design Pressure: -90 psf. (See General Limitation #9)



Membrane Type: Single Ply, Thermoplastic, TPO, VersiFleece
Deck Type 4: Celcore Lightweight Insulating Concrete, over Structural Concrete Deck
Deck Description: Celcore Lightweight Insulating Concrete, minimum 300 psi.
System Type F(2): Membrane fully adhered to lightweight insulating concrete deck.

All General and System Limitations apply. Roof accessories not listed in Table 1 of this NOA are not approved and shall not be installed unless said accessories demonstrate compliance with prescriptive Florida Building Code requirements and are field fabricated utilizing the approved membranes listed in Table 1.

Vapor Retarder: None

Membrane: VersiWeld or VersiWeld HS 45 or 60mil or VersiWeld Plus TPO 80 mil membrane fully adhered to the lightweight deck using VersiWeld Bonding adhesive applied at a rate of 1gal./60ft². (finished surface). or Aqua Base 120 Bonding Adhesive applied to the substrate at a rate of 1gal./120ft². (finished surface). Outside 1.5” of side laps are heat welded.
Or
VersiFleece TPO 100 or 115 mil membrane fully adhered to the lightweight deck using DASH Adhesive applied at a rate of 1 gal./sq. Outside 1.5” of side laps are heat welded.

Maximum Design Pressure:
-232.5 psf. with VersiFleece TPO & DASH Adhesive
-135 psf using VersiWeld & VersiWeld Bonding Adhesive
-82.5 psf using VersiWeld & Aqua Base 120 Bonding Adhesive
(See General Limitation #9 for all options)



Membrane Type: Single Ply, Thermoplastic, TPO, VersiFleece
Deck Type 4: Elastizell Range II Lightweight Insulating Concrete, over Structural Concrete Deck
Deck Description: Elastizell Range II Lightweight Insulating Concrete, minimum 300 psi.
System Type F(3): Membrane fully adhered to lightweight insulating concrete deck.

All General and System Limitations apply. Roof accessories not listed in Table 1 of this NOA are not approved and shall not be installed unless said accessories demonstrate compliance with prescriptive Florida Building Code requirements and are field fabricated utilizing the approved membranes listed in Table 1.

Vapor Retarder: None

Membrane: VersiWeld or VersiWeld HS 45 or 60mil or VersiWeld Plus TPO 80 mil membrane fully adhered to the lightweight deck using VersiWeld Bonding adhesive applied at a rate of 1gal./60ft². (finished surface). or Aqua Base 120 Bonding Adhesive applied to the substrate at a rate of 1gal./120ft². (finished surface). Outside 1.5” of side laps are heat welded.
Or
VersiFleece TPO 100 or 115 mil membrane fully adhered to the lightweight deck using DASH Adhesive applied at a rate of 1 gal./sq. Outside 1.5” of side laps are heat welded.

Maximum Design Pressure:

-90 psf. with VersiFleece TPO & DASH Adhesive
-67.5 psf using VersiWeld & Aqua Base 120 Bonding Adhesive
-90 psf using VersiWeld & VersiWeld Bonding Adhesive
(See General Limitation #9 for all options)




LIGHTWEIGHT INSULATING CONCRETE SYSTEM LIMITATIONS:

1. If mechanical attachment to the structural deck through the lightweight insulating concrete is proposed, a field withdrawal resistance testing shall be performed to determine equivalent or enhanced fastener patterns and density. All testing and fastening design shall be in compliance with Testing Application Standard TAS 105 and Roofing Application Standard RAS 137, calculations shall be signed and sealed by a Florida registered Professional Engineer, Registered Architect, or Registered Roof Consultant.
2. For steel deck application where specific deck construction is not referenced: The deck shall be a minimum 22 gage attached with 5/8” puddle welds with weld washers at every flute with maximum deck spans of 5 ft. o.c.
3. For Systems where specific lightweight insulating concrete is referenced consult current lightweight insulating concrete NOA for specific deck construction and limitations. For systems where specific lightweight insulating concrete is not referenced, the minimum design mix shall be a minimum of 300 psi.



GENERAL LIMITATIONS:

1. Fire classification is not part of this acceptance, refer to a current Approved Roofing Materials Directory for fire ratings of this product.
 2. Insulation may be installed in multiple layers. The first layer shall be attached in compliance with Product Control Approval guidelines. All other layers shall be adhered in a full mopping of approved asphalt applied within the EVT range and at a rate of 20-40 lbs./sq., or mechanically attached using the fastening pattern of the top layer
 3. All standard panel sizes are acceptable for mechanical attachment. When applied in approved asphalt, panel size shall be 4' x 4' maximum.
 4. An overlay and/or recovery board insulation panel is required on all applications over closed cell foam insulations when the base sheet is fully mopped. If no recovery board is used the base sheet shall be applied using spot mopping with approved asphalt, 12" diameter circles, 24" o.c.; or strip mopped 8" ribbons in three rows, one at each sidelap and one down the center of the sheet allowing a continuous area of ventilation. Encircling of the strips is not acceptable. A 6" break shall be placed every 12' in each ribbon to allow cross ventilation. Asphalt application of either system shall be at a minimum rate of 12 lbs./sq. **Note: Spot attached systems shall be limited to a maximum design pressure of -45 psf.**
 5. Fastener spacing for insulation attachment is based on a Minimum Characteristic Force (F') value of 275 lbf., as tested in compliance with Testing Application Standard TAS 105. If the fastener value, as field-tested, are below 275 lbf. insulation attachment shall not be acceptable.
 6. Fastener spacing for mechanical attachment of anchor/base sheet or membrane attachment is based on a minimum fastener resistance value in conjunction with the maximum design value listed within a specific system. Should the fastener resistance be less than that required, as determined by the Building Official, a revised fastener spacing, prepared, signed and sealed by a Florida Registered Engineer, Architect, or Registered Roof Consultant may be submitted. Said revised fastener spacing shall utilize the withdrawal resistance value taken from Testing Application Standards TAS 105 and calculations in compliance with Roofing Application Standard RAS 117.
 7. Perimeter and corner areas shall comply with the enhanced uplift pressure requirements of these areas. Fastener densities shall be increased for both insulation and base sheet as calculated in compliance with Roofing Application Standard RAS 117 and/or RAS 137. Calculations prepared, signed and sealed by a Florida registered Professional Engineer, Registered Architect, or Registered Roof Consultant **(When this limitation is specifically referred within this NOA, General Limitation #9 will not be applicable.)**
 8. All attachment and sizing of perimeter nailers, metal profile, and/or flashing termination designs shall conform with Roofing Application Standard RAS 111 and applicable wind load requirements.
 9. The maximum designed pressure limitation listed shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners). **(When this limitation is specifically referred within this NOA, General Limitation #7 will not be applicable.)**
 10. All membranes or packaging shall bear the imprint or identifiable marking of the manufacturer's name or logo and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.
- A black oval seal with the text "MIAMI-DADE COUNTY" in white above "APPROVED" in white.
11. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
