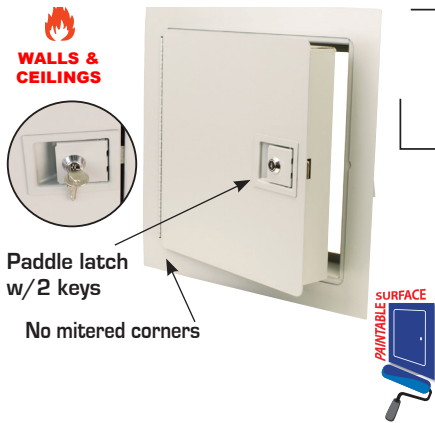
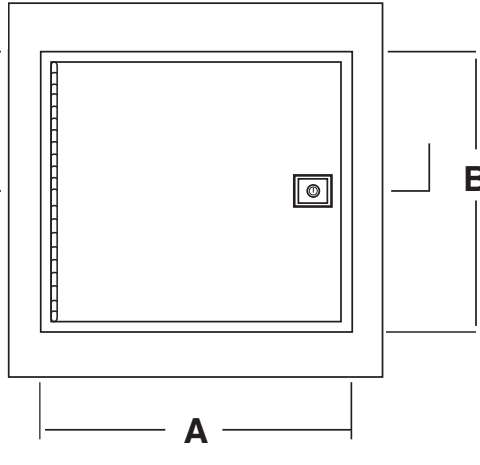

- Hinge: Continuous piano type hinge. Allows opening to 140°
- Insulation: 2" thick mineral wool
- Ceiling Installation: Largest size acceptable is 24" x 36"

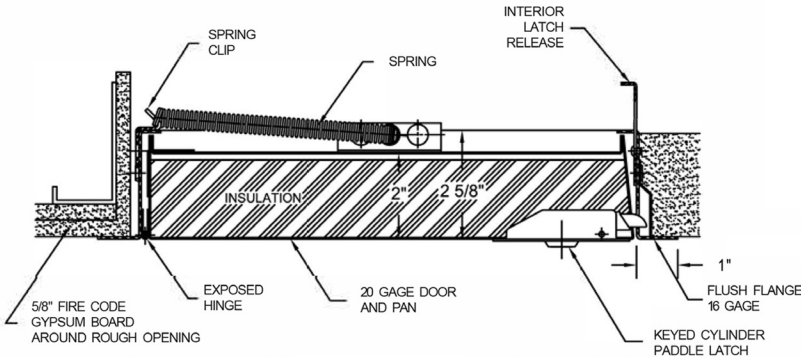
